Pursuant to authority vested in the BOARD OF EXAMINERS IN OPTOMETRY by sections Chapter 153.03(4) Wisconsin Statutes, the Board hereby amends Wisconsin Administrative Code, Section Opt 7.06(1) to read as follows:

Opt 7.06(1) The use of bold face type or any other means of attempting to attract special attention to himself in any telephone or other public directory, newspaper, or any other communication media including newspapers, magazines, television, radio broadcasts, or any other advertising matter distributed to the public.


THE AMENDMENT SHALL TAKE EFFECT AS PROVIDED IN SECTION 227.026(1) WISCONSIN STATUTES.
