

Pursuant to authority vested in the Division of Motor Vehicles of the Department of Transportation of the State of Wisconsin under 341.35 (4) and (5)(d), Wis. Stats., James L. Karns, the Administrator of said division hereby adopts the rules set forth in full infra, certifying that Statutory notice in accordance with 227.02 (1)(e), Wis. Stats., was given on such rules in the Wisconsin Administrative Register; and,

That the statutory 30 days under the aforesaid subsection of the statute has expired and no petition for public hearing on this proposal has been made by 25 persons affected by the rules, or a municipality which will be affected by the rules, or an association which is representative of a farm, labor, business or professional group which will be affected by such rules.

THEREFORE, IT IS HEREBY ORDERED, That Chapter MVD 7 of the Wisconsin Administrative Code, is hereby created and adopted as follows:

CHAPTER MVD 7 - MUNICIPAL REGISTRATION FEE

**7.01 Notice of Adoption.** All municipal governing bodies enacting an ordinance adopting a municipal vehicle registration fee in accordance with 341.35, Wis. Stats., shall give immediate notice thereof to the Division of Motor Vehicles, Department of Transportation of the State of Wisconsin, in accordance with 341.35 (4), Wis. Stats., in format as follows:
