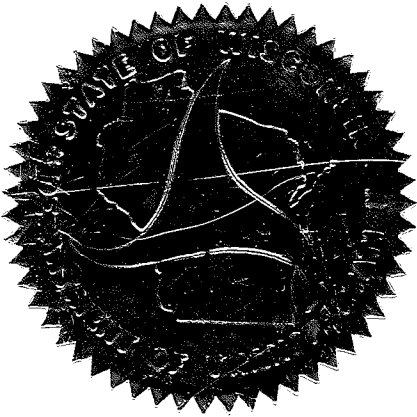

MVD 4 OF THE WISCONSIN ADMINISTRATIVE \* RECREATING AND CREATING  
CODE. \*

Pursuant to authority vested in the Administrator of the Division of Motor Vehicles of the Wisconsin Department of Transportation under 110.06, Wis. Stats., and specifically in 194.09, Wis. Stats.; and, after due notice and public hearing held the 12th day of December 1968, at 9:00 a.m., at the Hill Farms State Office Building, 4802 Sheboygan Avenue, Madison, Wisconsin; and, after due consideration to the objections and suggestions of those persons attending such public hearing relative to the various portions of the rules;

IT IS HEREBY ORDERED, That Chapter MVD 4 of the Wisconsin Administrative Code, relative to lettering on carrier vehicles, display of evidence of registration and dual permit and related matters, be amended, renumbered, recreated and created as follows:

1. Repeal and recreate Section MVD 4.01 (6)(b) to read:

(b) A private carrier renting a vehicle from a rental company or leasing a vehicle from a leasing company for a period of 30 days or less.

2. Renumber MVD 4.03 to read MVD 4.03 (1) and amend as follows:

MVD 4.03 (1) Display of registration certificate. No vehicle subject to Chapter 194, Wis. Stats., shall be operated upon the highways of Wisconsin unless it carries the current registration, reciprocity, or dual permit or lessor permit certificate issued by the licensing agency, or evidence that application has been made for the appropriate registration.

3. Create Section MVD 4.03 (2).

MVD 4.03 (2) Lessor plates issued under Chapter 194, Wis. Stats., shall be prominently displayed on the front of the power equipment and on the rear of semi-trailers or trailers.
