ORDER OF THE DEPARTMENT OF AGRICULTURE RENUMBERING AND ADOPTING RULES

Pursuant to authority vested in the Department of Agriculture by sections 93.07 (1) and 97.24, Wis. Stats., the Department of Agriculture hereby renumbers and adopts rules as follows:

1. Section Ag 80.01 (13) of the Wisconsin administrative code is renumbered Ag 80.01 (13) (a).

2. Sections Ag 80.01 (13) (b) and (c) of the Wisconsin administrative code are adopted to read:

Ag 80.01 (13) (b) Cultured skim milk or cultured low fat milk is a fluid or semifluid product resulting from the souring or treatment by lactic acid or other culture of pasteurized skim milk or pasteurized low fat milk. It contains not less than 8.5% milk solids not fat. Flavoring, lactose, and harmless stabilizers and emulsifiers may be added.

(c) Yogurt or yoghurt is the product resulting from the souring or treatment by lactic acid or other culture of pasteurized milk, low fat milk, or skim milk. It contains not less than 8.5% milk solids not fat. Flavoring, lactose, and harmless stabilizers and emulsifiers may be added. If made with added fruit, the resulting product shall be labeled "Yogurt with

", the blank being filled in with the name of the fruit. Yogurt flavored with a flavoring material shall be labeled "______ Flavored Yogurt", the blank being filled in with the name of the flavoring material. The coliform standards of Wis. Adm. Code section Ag 80.06 shall apply at the

point of production prior to the addition of flavoring or fruit.

3. Sections Ag 80.01 (22) and (23) of the Wisconsin administrative code are renumbered Ag 80.01 (24) and (25).

4. Sections Ag 80.01 (22) and (23) of the Wisconsin administrative code are adopted to read:

Ag 80.01 (22) Skim milk or skimmed milk is milk from which a sufficient portion of milk fat has been removed to reduce its milk fat content to less than 0.5%. It shall contain at least 8.5% milk solids not fat. Milk solids or lactose may be added.

(23) Low fat milk is milk from which a sufficient portion of milk fat has been removed to reduce its milk fat content to not less than 0.5% and not more than 2.0%. It shall contain not less than 8.5% milk solids not fat. Milk solids or lactose may be added. Low fat milk shall be clearly labeled to indicate the percentage of butterfat contained therein.

5. Section Ag 80.16 of the Wisconsin administrative code is renumbered Ag 80.17.

6. Section Ag 80.16 of the Wisconsin administrative code is adopted to read:

Ag 80.16 All bottles, containers and packages of Grade A milk and Grade A milk products shall be labeled or marked with the name of the contents; the grade of contents; the word "pasteurized" if the contents are pasteurized; vitamin and mineral fortification as required in Wis. Adm. Code section Ag 71.04; the percentage by weight of nonfat milk solids added and/or the percentage by weight of lactose added; and the common name of stabilizers, emulsifiers, distillates and other permitted

optional ingredients.

The rules contained herein shall take effect as provided in section 227.026, Wis. Stats.
