

**Chapter ERB 8****HEARINGS, (Section 111.57, Wis. Stats.)**

**ERB 8.01 Time and place of hearing.** The Wisconsin employment relations commission shall fix the time and place for the commencement of the initial hearing.

**ERB 8.02 Arguments; briefs.** Oral arguments may be made by any of the parties to the dispute at the conclusion of the hearing. Briefs may be filed by any of the parties provided permission to file such briefs is obtained from the board of arbitration and provided further that such briefs may be filed no later than eight days prior to the time the board of arbitration must make and file its decision as provided in section 111.59, Wis. Stats.

**ERB 8.03 Evidence.** The board of arbitration shall receive all relevant and competent evidence any of the parties may desire to offer. It shall in no case, however, receive in evidence or consider in any way any offers of settlement made by either party during the attempted conciliation of the dispute.

**ERB 8.04 Hearing may be reopened.** The hearing may be reopened by the board of arbitration on its own motion or upon application of any party for good cause shown at any time before the award is made.
