Pursuant to authority vested in the Division of Motor Vehicles of the Department of Transportation of the State of Wisconsin as provided in 110.06, Wis. Stats.; and, under authority of 227.02 (1)(e), Wis. Stats., James L. Karns, the Administrator of the Division of Motor Vehicles, hereby creates the rules set forth in full infra, certifying that Statutory notice was given on such rules in the Wisconsin Administrative Register; and,

That the statutory 30 days under the aforesaid subsection of the statutes has expired and no petition for public hearing on this proposal has been made by 25 persons affected by the rules, or a municipality which will be affected by the rules, or an association which is representative of a farm, labor, business or professional group which will be affected by such rules.

THEREFORE, IT IS HEREBY ORDERED, That Chapter MVD 15 of the Wisconsin Administrative Code is hereby amended by creation of MVD 15.01 (4) and

15.01 (1) (am), as follows:

MVD 15.01 (4) Telephone requests for searches.

Requests for driver record searches may be accepted by telephone by the division of motor vehicles subject to the following procedure and special fees.

Any person who desires special telephone service must request such service in writing. Upon receipt of such written request, the person will be required to sign a customer agreement to pay a special fee of \$1.50 for each file search. The division will bill each customer each month for the number of searches made on his request. Prompt payment of the fees shall be required. Further requests will be refused if payment is not promptly made.

The requestor will be required to identify himself and his company and may be assigned a code or customer number or such further identification as the division may require.

MVD 15.01 (1)(am).

The bureau of registration may, in lieu of the per item charge as provided in (1)(a) supra, charge on an hourly rate depending on the nature and volume of the search.
