
ORDER OF

In connection with the adoption of our new Wisconsin Administrative Code Chapter 12, Work Under Compressed Air, we are repealing the regulations related to this work in our current code, Chapter 6, Trench, Excavation and Tunnel Construction.

In repealing the referenced regulations we desire a notification to be inserted in place of what now appears as "Part IV Additional Rules For Work When Done Under Compressed Air" on page 27 of the present code of Chapter 6. The new notice should read "For Rules Covering Work Under Compressed Air See Wis. Adm. Code, Chapter 12, Work Under Compressed Air."
