

ORDER OF THE PHARMACY EXAMINING BOARD ADOPTING RULES

Pursuant to authority vested in the Pharmacy Examining Board by sections 450.01 (5) and 227.021, Wis. Stats., the Pharmacy Examining Board hereby adopts rules as follows:

Sections Chapter Phar 5 of the Wisconsin administrative code are adopted to read:

Chapter Phar 5

Fee Schedule

Phar 5.01	Scope	5.03	Intern Registration Fee
Phar 5.02	Examination Fee	5.04	License Fees

Phar 5.01 Scope. The fees fixed in this code shall be collected by the Pharmacy Examining Board for examination, licensure, license renewal and for all other registrations and services for which authority to fix and collect fees is provided in Chapter 450, Wis. Stats.

Phar 5.02 Examination Fee. Applicants for original licensure as a pharmacist shall pay an examination fee of \$55 at least 15 days before the date of examination. The fee for all subsequent examinations shall be \$45.

Phar 5.03 Intern Registration Fee. The annual fee for registration as a pharmacy intern shall be \$10.

Phar 5.04 License Fees. (1) Pharmacist Renewal. Renewal applicants for a pharmacist's license shall pay a license fee of \$21 annually. Of this fee, \$11 shall be set aside for use by the pharmacy internship board exclusively for purposes of the internship program.

(2) Pharmacy Renewal. Renewal applicants for a pharmacy license shall pay a license fee of \$45 annually.

(3) Permit. An applicant for a rural drug permit shall pay an annual permit fee of \$15.


(4) Manufacturer. Every person who manufactures, packages, or prepares any drugs or medicines within this state shall pay an annual permit fee of \$30.

(5) Distributor. Every person who distributes drugs at wholesale in accordance with Wis. Stat 450.04 (5) shall pay an annual permit fee of \$30.

The rules contained herein shall take effect on March 1, 1972, as provided in section 227.026, Wis. Stats.
