ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

ADOPTING AND AMENDING RULES

Pursuant to authority vested in the State of Wisconsin Natural Resources Board by sections 23.09, 23.11, 28.02 and 227.02, Wisconsin Statutes, the Natural Resources Board hereby adopts and amends rules as follows:

SECTION I. NR 40.07 (44) of the Wisconsin Administrative Code is renumbered to be NR 40.07 (45).

SECTION II. NR 40.07 (44) of the Wisconsin Administrative Code is created to read:


NR 40.07 (44) Also including Government Lot 3, and that portion of Government Lot 4, and that part of the NE 1/4 SW 1/4 lying north of County Trunk Highway "U", all in Section 24, T40N-R17W.
