## ORDER OF THE PUBLIC SERVICE COMMISSION

#### ADOPTING AND REPEALING RULES

Pursuant to authority vested in the Public Service Commission by Chapter 194, Wis. Stats., the Public Service Commission hereby repeals and amends rules as follows:

Wis. Adm. Code section PSC 50.02 (intro. par.) and (9) are amended to read:

PSC 50.02 Restricted highways. No such motor carrier shall, except by special permission of the commission, operate any motor vehicle of more than 10,000 pounds total weight between the hours of 1:00 P.M. and 10:00 P.M. on Saturdays or between the hours of 9:00 A.M. and 10:00 P.M. on Sundays or legal holidays from May 24 to the second Sunday in September, both inclusive, upon any of the following highways, including highways which may coincide with said highways unless specifically exempted herein, described in accordance with the numbering on the current official highway map, except at intersections of such described highways with highways not included in this chapter, and except within the corporate limits of cities and villages:

(9) HIGHWAY 45--Between West Bend and Fond du Lac.

Wis. Adm. Code section PSC 50.02(5), (7), and (13) are repealed.

Wis. Adm. Code section PSC 50.03(2) is amended to read:

PSC 50.03(2) None of the classes of traffic named in PSC 50.03(1)(c) shall include articles packed in hermetically sealed containers, nor shall the empty return vehicles, except vehicles used exclusively for the transportation of milk directly from the farms to the dairies, use the restricted highways when such vehicle exceeds 10,000 pounds in weight except where reasonably adequate alternate routes are not available.

The amendments and repeals contained herein shall take effect on May 1, 1974, as provided in section 227.026(1), Wis. Stats.
