ORDER OF

DEPARTMENT OF INDUSTRY, LABOR AND HUMAN RELATIONS

Pursuant to authority vested in the Department of Industry, Labor and Human Relations by sections 101.01 to 101.20, Wis. Stats., the Department of Industry, Labor and Human Relations hereby amend, repeals and recreates and adopts rules of Wisconsin Administrative Code Chapters Ind 49--Migrant Labor Camps.

The rules attached hereto shall become effective on the first day of the month following publication in the Wisconsin Administrative Code as provided in section 227, Wis. Stats. Subsection Ind 49.08 (3) (d) to be repealed.

Subsection Ind 49.08 (3) "Note" to be created to read:

Note: The space requirements of (3) are in accordance with the Federal Register, Volume 33, Number 213, Thursday, October 31, 1968, Title 20-Employe's Benefits, Chapter V-Bureau of Employment Security, Department of Labor, Part 620-Housing for Agricultural Workers, Section 620.7 (c)(1), (2) & (3).

An interpretation by definition issued April 1, 1970 in the Employment Security Manual, section 2031M.states: "Space Requirements. For children under 12 years of age, space requirements are one-half that required for occupants in quarters used for combined cooking, eating and sleeping purposes."

This interpretation will be considered by the department in certifying migrant labor camps for compliance with (c).

Subsection Ind 49.13 (2) (c) (intro. par.) to be amended to read:

(c) When common use shower facilities for both sexes are in the same building, the facilities shall be separated by a solid opaque and nonabsorbent wall extending from the floor to ceiling, or roof, and shall be plainly designated "men" or "women" in English and in the native language of the persons expected to occupy the housing.

Subsection Ind 49.14 (3) (a) 8. to be amended to read:

8. Handwashing facilities shall be provided in kitchens and shall include hot and cold water under pressure, soap, and individual toweling for use by kitchen personnel only.

Subsection Ind 49.14 (3) (a) 10. (intro. par.) to be amended to read:

10. A sink with ample facilities for providing hot and cold water under pressure shall be provided for washing dishes and kitchen utensils.

Subsection Ind 49.18 (4) to be repealed and recreated to read:

- (4) Sleeping and common use rooms located on or above the second story shall comply with the state and local fire and building codes relative to multi-story dwellings.
 - (a) Exception: on two-story buildings a modified class 'A' fire escape constructed of wood may be provided as a second exit serving not more than eight persons.
 - 1. The fire escape and its connectors shall be capable of supporting
