ORDER OF THE EXAMINING BOARD OF ARCHITECTS, PROFESSIONAL ENGINEERS, DESIGNERS AND LAND SURVEYORS ADOPTING AND AMENDING RULES

Pursuant to authority vested in the Examining Board of Architects, Professional Engineers. Designers and Land Surveyors by sections 15.08, 227.014, 443.01 and 443.02, Wis. Stats., the Examining Board of Architects, Professional Engineers, Designers and Land Surveyors hereby amends and adopts rules as follows:

Section A-E 1.18 of the WISCONSIN ADMINISTRATIVE CODE is adopted to read:

A-E 1.18. Educational Requirements For Land Surveyors. To meet the educational requirements of Wis. Stat. s. 443.02(3)(a)1. requiring "... a course in land surveying of not less than 2 years duration approved by the section ... " an applicant for registration as a land surveyor must have satisfactorily completed at least 60 semester credits in a civil engineering or land surveying curricula including no less than 12 semester credits in land surveying subjects.

Section A-E 4.07(3) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

A-E 4.07(3) No architect, professional engineer, designer or land surveyor shall allow work performed by him or under his personal direction and control to be signed, sealed or stamped by another architect, professional engineer, designer or land surveyor except that an architect, professional engineer, designer or land surveyor working under the personal direction and control of another registrant may allow that registrant to sign and seal or stamp said work.

The rules and amendments contained herein shall take effect on the first day of the month following their publication in the Wisconsin Administrative Register.
