# ORDER OF THE DEPARTMENT OF PUBLIC INSTRUCTION ADOPTING RULES

Pursuant to authority vested in the Department of Public Instruction by s. 115.28 (9), s. 115.77, and s. 227.01 (3) and (4), Wis. Stats., the State Superintendent of Public Instruction for the State of Wisconsin hereby adopts rules as follows:

Sections 10.01 through 10.08 of the WISCONSIN ADMINISTRATIVE CODE are hereby adopted to read:

- 10.01 HEARING IMPAIRED CHILDREN IN NEED OF AMPLIFICATION AND SERVICES
  - 1. Eligibility Requirements:
    - a. The child shall be under 21 years of age. Children over 16 years of age may be referred to Vocational Rehabilitation for services.
    - b. Diagnosis shall be established by a physician who is on the Bureau for Crippled Children's (BCC) list of participating physicians.
    - c. Further hearing assessment and hearing aid evaluation shall be completed by a clinical audiologist who is on the BCC list of participating clinical audiologists.
    - d. Financial eligibility shall be determined by the latest standards as developed by the BCC.

### 10.02 SERVICES AVAILABLE

- 1. The Bureau for Crippled Children may assist in:
  - a. Providing for medical examination, consultation and treatment.
  - b. Providing for audiological evaluation and consultation.
  - c. Providing for assistance in referral for educational services.
  - d. Providing for nursing consultation.
  - e. Providing for referral for social work services and consultation.

#### 10.03 FINANCIAL SERVICES

- 1. Requirements regarding medical and surgical costs.
  - a. Payment may be made for hearing assessment and hearing aid evaluation for medically indigent families to a clinical audiologist who is on the BCC list of participating clinical audiologists.

b. Payment shall be made for hearing aids (all or in part) for medically indigent families. Fitting shall be approved by a clinical audiologist who is on the Bureau list of participating clinical audiologists.

#### 10.04 PROCEDURES

- 1. For the administration of medical care and audiological assessment:
  - a. The results and recommendations of the physician's examination shall be forwarded to the BCC clinical audiologist.
  - b. The results and recommendations of the assessment by the clinical audiologist shall be forwarded to the BCC clinical audiologist.
  - c. The results and recommendations of the assessment by the clinical audiologist, including pertinent information regarding the fitting of the hearing aid, shall also be shared with the hearing aid specialist.
  - d. The parent of the child shall designate the hearing aid specialist who will fit the hearing aid.
  - e. The hearing aid specialist shall be licensed to dispense hearing aids in the State of Wisconsin. The hearing aid specialist shall also follow the rules for financial involvement in the purchase of hearing aids.
  - f. If the BCC pays the full cost of the hearing aid or accessory, the designated hearing aid specialist shall not charge any additional amount. In those cases where a percentage of the cost for any hearing aid or accessory is paid by the BCC, the designated hearing aid specialist shall only charge the recipient of services the remaining amount of the standard fee determined by the BCC.
  - g. The parent receiving aid for payment of services shall have the child return to the clinical audiologist for a final check of the hearing aid before any monies are paid. In the event the parent is unwilling or unable to return the child to the clinical audiologist following the fitting of the hearing aid, consultation with the BCC audiologist shall be required.
  - h. The hearing aid specialist shall confer with the clinical audiologist concerning any modification in the fitting of the hearing aid.

- i. A financial eligibility form shall be submitted to the BCC and written approval shall be received by the parent prior to rendering of and payment for any services.
- j. Reimbursement shall be made only to the provider of care and not to the recipient of service. Where there is medical insurance coverage, the provider shall submit the claim and the BCC will pay the amount not covered by insurance.

#### 10.05 PARTICIPATING CLINICAL AUDIOLOGISTS

## 1. Requirements:

- a. Shall complete graduate studies in audiology leading to a master's and/or higher graduate degree.
- b. Shall submit evidence of having completed 300 hours of supervised clinical experience and 60 hours of course work in audiology and related areas.
- c. Shall complete an additional year of full-time supervised clinical internship in audiology or be in the process of completing this requirement.
- d. Shall pass the National Examination in Audiology administered by the Educational Testing Service, Princeton, New Jersey, or who have received a Certificate of Clinical Competence in Audiology.
- e. Persons wishing to be included on the state agencies' list of participating clinical audiologists must submit evidence that the above requirements have been met. Those clinical audiologists who are in the process of meeting the certification standards outlined above will be reviewed individually for participation in this program. Any other person not meeting these requirements may present his/her qualifications to the BCC audiologists for review and consideration.
- f. Membership in any professional association is not required.
- g. All information pertaining to the above requirements shall be submitted in writing to BCC clinical audiologists, Room 614, Bureau for Crippled Children, 126 Langdon Street, Madison, Wisconsin 53702.

## 10.06 PARTICIPATING CLINICAL AUDIOLOGISTS

- 1. Procedures:
  - a. In every case where the BCC is involved in payment, a complete report shall be made to the BCC within two weeks of completion of the evaluation.
  - b. In all cases where audiometric evaluation has indicated abnormal hearing, arrangements shall be made for an examination of the ear by a physician specializing in diseases of the ear.
  - c. A complete report shall be submitted to the BCC clinical audiologist. It shall include all pertinent information and a complete audiogram. Educational programming recommendations from the audiologists are desired but specific educational placement shall be the responsibility of the local educational agency.

## 10.07 CLINICAL AUDIOLOGISTS DISPENSING HEARING AIDS

- 1. Procedures:
  - a. Shall meet the BCC requirements for participating clinical audiologists in order to qualify for reimbursement for services rendered.
  - b. Any reference to state agencies in advertising or promotion of any kind is prohibited.
  - c. Facilities utilized in evaluating the recipient of BCC services shall meet the approval of the BCC.

#### 10.08 DEFINITIONS

- 1. Participating Physicians:
  - a. Licensed physicians who have demonstrated their competence and are certified by the American Board of Otolaryngology, American Academy of Opthalmology and Otolaryngology, and some others as determined by the BCC.
- 2. Participating Clinical Audiologists:
  - a. Those clinical audiologists who have met the requirements of the BCC.

- 3. Participating Clinical Audiologists Dispensing Hearing Aids:
  - a. Those clinical audiologists who have met the requirements of the BCC. They shall be licensed in the state of Wisconsin to dispense, fit and service hearing aids.
- 4. Bureau for Crippled Children's Clinical Audiologists:

- 5 -

- a. Those clinical audiologists employed by the Department of Public Instruction, Bureau for Crippled Children, to administer the Wisconsin State Hearing Conservation Program.
- 5. Participating Hearing Aid Specialists:
  - a. Hearing aid specialists licensed in the state of Wisconsin who have agreed to supply hearing aids and services pursuant to the above rules.
- 6. Bureau for Crippled Children's List of Participating Physicians, Clinical Audiologists, and Hearing Aid Specialists:
  - a. Those physicians, clinical audiologists and hearing aid specialists who have agreed to work with the BCC pursuant to these rules.

7. Parent:

a. Includes legal guardian of child.

The rules contained herein shall take effect on the first day of the month following its publication in the Wisconsin administrative register as provided in s. 227.026, Wis. Stats.
