

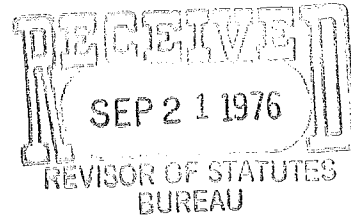

ORDER OF THE STATE HIGHWAY COMMISSION
AMENDING RULES

Pursuant to authority vested in it by Sections 118.08(3), 349.08(1), 349.11(5) and 349.16(2), Wisconsin Statutes, the Highway Commission hereby amends portions of its rules as follows:

Section Hy 12.01(2) is amended to read:

Hy 12.01(2) *Permissive Interim Compliance With Standards*. Signs which comply with Chapter Hy 12 as published in the Wisconsin Administrative Register for April, 1967, may be used until January 1, ~~1976~~ 1978, but after December 31, 1972 all new school sign installations and after December 31, ~~1975~~ 1977, all signs covered by this Chapter and their installation shall comply with these rules.

Section Hy 13.01(2) is amended to read:

Hy 13.01(2) *Permissive Interim Compliance With Standards*. Signs which comply with Chapter Hy 13, as published in the Wisconsin Administrative Register for April, 1967 may be used before January 1, ~~1976~~ 1978, but after December 31, 1972 all new Speed Limit sign installations and after December 31, ~~1975~~ 1977, all Speed Limit signs shall comply with these rules.

Section Hy 14.01(2) is amended to read:

Hy 14.01(2) *Permissive Interim Compliance With Standards*. Signs which comply with Chapter Hy 14 as published in the Wisconsin Administrative Register for June, 1967, may be used before January 1, ~~1976~~ 1978, but after December 31, 1972 all new Weight Limit sign installations and after December 31, ~~1975~~ 1977, all signs covered by these rules shall comply with these rules.

Section Hy 18.01(2) is amended to read:

Hy 18.01(2) *Permissive Interim Compliance With Standards*. Yield signs which comply with Chapter Hy 18 as published in the Wisconsin Administrative Register for April, 1967, may be used before January 1, ~~1976~~ 1978, but after December 31, 1972 all new yield sign installations and after December 31, ~~1975~~ 1977, all yield signs and their installation and use shall comply with these rules.

Section 21.02 is amended to read:

Hy 21.02 Effective date of regulations. Traffic control signals which comply with Chapter Hy 21 as published in the Wisconsin Administrative Register for January, 1970, may be operated until January 1, ~~1977~~ 1978, but all new traffic control signal installations made after December 31, 1972 and all traffic control installations in place and operating after December 31, ~~1976~~ 1977 shall comply with these rules.

Section Hy 22.02 is amended to read:

Hy 22.02 Effective date of regulation. Flashing traffic beacons which comply with Chapter ~~24~~ 22 as published in the Wisconsin Administrative Register for April, 1967, may be operated until January 1, ~~1977~~ 1978, but all new flashing traffic beacons installed after December 31, 1972 and all flashing traffic beacons in place and operating after December 31, ~~1976~~ 1977 shall comply with these rules.
