ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD

AMENDING AND CREATING RULES

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by section 144.21 and chapter 227, Wisconsin Statutes, the Natural Resources Board hereby amends and creates rules as follows:

SECTION 1 - Section NR 125.03 (2) (k) is created to read:

(k) A project that receives a Step III construction grant under P.L. 92-500 as amended.

SECTION 2 - Section NR 125.11 (2) is amended to read:

(2) Amount of grant offer. A state grant shall not exceed 25% of the eligible costs of an approved project. The state grant plus grants from other nonlocal sources shall not exceed 75% of the eligible project cost.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on June 17, 1976.

The rules contained herein shall take effect upon publication.
