

## ORDER OF THE

## WISCONSIN REAL ESTATE EXAMINING BOARD REPEALING & RECREATING RULES

Pursuant to authority vested in the Wisconsin Real Estate Examining Board by section 15.08(5), Wis. Stats., the Wisconsin Real Estate Examining Board hereby repeals and recreates rules as follows:

Section REB 2.035 of the Wisconsin Administrative Code is repealed. Section REB 2.035 of the Wisconsin Administrative Code is recreated to read:

REB 2.035 Review of examinations and examination results. (Section 452.05(2)Stats.) (1) All applicants shall be offered the opportunity to review their examinations and make written comments and objections at the time and place that they take the examination.

(2) Reports. All applicants who obtain a failing grade shall receive, for facilitating further study, a report detailing the results in the major content areas of the examination.

(3) Written review. All applicants who receive failing, grades may request a written review of the results of the examination.

The rules and repeals contained herein shall take effect on December 1, 1978.
