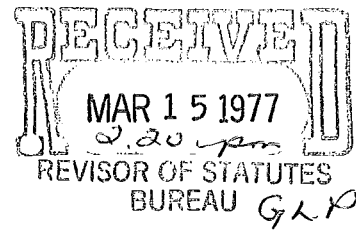



ORDER OF THE DEPARTMENT OF PUBLIC INSTRUCTION
REPEALING RULES

Pursuant to the authority vested in the Department of Public Instruction by Sections 43.03 and 43.09, Wisconsin Statutes, the State Superintendent of Public Instruction hereby repeals rules as follows:

Section FLC 1, Section 1.01 through 1.05, in its entirety, is repealed.



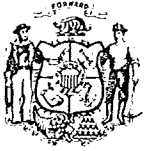

Dear Mr. Berger:

This will acknowledge receipt of your letter of March 7, 1977, with reference to Chapter FLC 1, Section 1.01 through 1.05. The Department of Public Instruction, in March of 1972, filed an order which was intended to repeal this Section and Chapter FLC 2. The wrong section number was apparently cited and only Chapter FLC 2 was repealed, leaving Chapter FLC 1 intact. However, Section PI 6.03 through 6.05 adopted the public librarian certification provisions and the provisional certification requirements for public library systems into Chapter PI 6, Volume 7 of the Wisconsin Administrative Code.

We are utilizing the procedures of Section 227.02 (1) (b) to repeal this rule without a hearing to bring it in line with the transfer of the functions of the Free Library Commission to the Department of Public Instruction by Chapter 150 of the Laws of 1965. Enclosed find a copy of the proposed order to repeal FLC 1.01 through 1.05.

Thank you very much for your letter advising us of this matter.
