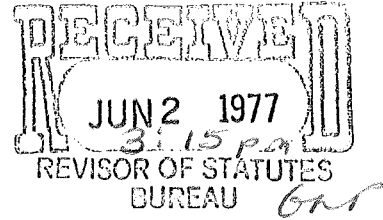



ORDER OF THE STATE OF WISCONSIN DEPARTMENT OF AGRICULTURE
AMENDING AND ADOPTING RULES

Pursuant to authority vested in the State of Wisconsin Department of Agriculture by sections 126.035(4) and 227.02(1)(b), Wis. Stats., the State of Wisconsin Department of Agriculture hereby amends and adopts rules as follows:

Chapter Ag 3

REGISTRATION OF WAREHOUSES

1. Chapter G-W 1 (title) is renumbered Chapter Ag 3.
2. Section G-W 1.01 of the Wisconsin Administrative Code is renumbered Ag 3.01 and amended to read:

Ag 3.01 ~~Application-for-registration-of-warehouses~~ Registration procedures. (1) APPLICATION. Any person ~~or-corporation~~ operating one or more public warehouses in the city of Superior under the ~~jurisdiction-of-this-commission~~ Chapter 126, Wis. Stats., may apply to the ~~secretary-of-this-commission~~ department and request that the warehouse receipts issued for commodities stored at such warehouse or warehouses be registered by and with ~~this commission~~ the department. All such applications shall be made in writing in a form acceptable to ~~this-commission~~ the department and shall be accompanied by a bond for the benefit of the state of Wisconsin and of the holders of registered warehouse receipts in a form and for an amount acceptable to ~~this-commission~~ the department, which bond shall be conditioned upon a strict compliance

with the regulations prescribed by ~~this-commission~~ the department for the registration of warehouse receipts, the issue thereof and the management of public warehouses wherein commodities are stored for which registered warehouse receipts are issued and shall further be conditioned upon the payment of such fees as may be fixed by ~~this-commission~~ the department for the registration of warehouse receipts and shall further be conditioned upon the strict compliance with the laws of the state of Wisconsin with respect to all public warehouses under the jurisdiction of ~~this-commission~~ the department, therefore, and by reason of this condition, being an additional security to the bond now given by all persons and ~~corporations~~ operating public warehouses under the jurisdiction of ~~this-commission~~ the department.

3. Section G-W 1.02 of the Wisconsin Administrative Code is renumbered Ag 3.01(2).

4. Section G-W 1.03 of the Wisconsin Administrative Code is renumbered Ag 3.01(3) and amended to read:

Ag 3.01(3) REGISTERED PUBLIC WAREHOUSE. Upon approval of the application and bond above referred to, ~~this-commission~~ the department will declare the warehouse or warehouses operated by the applicant and described in such application and bond as "Registered Public Warehouses" whereupon and thenceforth all warehouse receipts issued for commodities stored in the same shall be registered by and with ~~this-commission~~ the department until the next succeeding 30th day of June, provided ~~this-commission~~ the department does not exercise its power to revoke or recall its

action which power it hereby reserves. Applications for renewal shall be in all respects exactly the same as application made for the first time.

5. Section G-W 1.04 of the Wisconsin Administrative Code is renumbered Ag 3.01(4) and amended to read:

Ag 3.01(4) REGISTRAR. The registrar, who is an employee of ~~this-commission~~ the department, and who has given bond in the amount of \$25,000.00 conditioned upon the faithful discharge of any and all duties imposed upon ~~him~~ the registrar by ~~this-commission~~ the department and by law, ~~be-and-he~~ hereby is designated as warehouse registrar and it shall henceforth be ~~his~~ the duty of the registrar to act as such under the regulations prescribed by ~~this-commission~~ the department. The ~~commission~~ department will from time to time designate such assistant warehouse registrars as may be needed.

6. Section G-W 1.05 of the Wisconsin Administrative Code is renumbered Ag 3.01(5) and amended to read:

Ag 3.01(5) FEES. All bills for expenditures on account of the registration of warehouse receipts, including the salaries of the warehouse registrar and such assistant warehouse registrars as may be designated, shall be passed upon by ~~this-commission~~ the department as in the case of other disbursements and a sum of money sufficient to pay the same shall be collected at the end of each month, as registration fees, from the operators of registered public warehouses, each operator to pay in proportion to the volume, in terms of commodity units such as bushels, of ~~his-or-its~~ the operator's storage business.

7. Chapter G-W 2 (title) of the Wisconsin Administrative Code is renumbered Ag 3.02.

8. Section G-W 2.01 of the Wisconsin Administrative Code is renumbered Ag 3.02(1).

9. Section G-W 2.02 of the Wisconsin Administrative Code is renumbered Ag 3.02(2).

10. Chapter G-W 3 (title) of the Wisconsin Administrative Code is renumbered AG 3.03.

11. Section G-W 3.01 of the Wisconsin Administrative Code is renumbered Ag 3.03(1).

12. Section G-W 3.02 of the Wisconsin Administrative Code is renumbered Ag 3.03(2) and amended to read:

Ag 3.03(2) EXAMINATION OF RECEIPTS. When receipts are presented for registration the warehouse registrar or assistant warehouse registrar shall carefully compare the same with the returns and reports that shall have been made to ~~him~~ them, and if satisfied of the correctness of the same, shall stamp them with a proper stamp for the purpose, containing in legible letters the date of such presentation and the name of the warehouse registrar with the title of ~~his-office~~, "Warehouse Registrar", and the name of the city in which it was registered; but if it is found that any difference exists, a thorough examination into the reasons therefor shall be instituted, and such error shall be corrected before affixing the stamp; and if it shall appear that any fraud in the issuance of such receipt shall have been attempted by the warehouseman, the said warehouse registrar or assistant warehouse

registrar shall at once report the same to the ~~grain-and-warehouse~~
~~commission~~ department.

13. Section G-W 3.03 of the Wisconsin Administrative Code is
renumbered Ag 3.03(3).

14. Section G-W 3.04 of the Wisconsin Administrative Code is
renumbered Ag 3.03(4) and amended to read:

Ag 3.03(4) CANCELLATION. Cancelled registered warehouse re-
ceipts shall be void and not again placed in circulation and dupli-
cate receipts surrendered to a warehouseman shall be in turn pre-
sented by him the warehouseman to the warehouse registrar or assistant
warehouse registrar for check and cancellation and likewise shall
not again be placed in circulation.

15. Chapter G-W 4 (title) of the Wisconsin Administrative Code
is renumbered Ag 3.04.

16. Section G-W 4.01 of the Wisconsin Administrative Code is
renumbered Ag 3.04(1).

17. Section G-W 4.02 of the Wisconsin Administrative Code is
renumbered Ag 3.04(2).

18. Section G-W 4.03 of the Wisconsin Administrative Code is
renumbered Ag 3.04(3).

19. Section G-W 4.04 of the Wisconsin Administrative Code is
renumbered Ag 3.04(4).
