ORDER OF THE DEPARTMENT OF PUBLIC INSTRUCTION

AMENDING RULES

This is an order of the State Superintendent of Public Instruction, amending rules PI 3.02 (3), 3.03 (13), 3.03 (14), and 3.04 (3) (a) of the Wisconsin Administrative Code.

Pursuant to authority vested in the Department of Public Instruction by Section 115.28 (7), Wisconsin Statutes, the State Superintendent of Public Instruction hereby amends rules as follows:

That PI 3.02 (3) be amended to read:

PI 3.02 (3) The district administrator of the school must request such license in writing and must explain and justify the need.

That PI 3.03 (13) be repealed and recreated to read:

- PI 3.03 (13) REFRESHER WORK. (a) Teachers who have not been regularly employed within the teaching profession within the past 5 years, but who are endorsed by a college or university as having completed an Approved Teaching Program, may be issued a one-year license upon the written request of an employing district administrator. Renewal of this licensure to a regular term license is dependent upon the completion of 6 semester hours of refresher work: in methods and/or academic subjects.
- (b) A regular term license may be granted to applicants who are endorsed by a college or university as having completed an Approved Teaching Program and who present evidence of 6 semester hours of refresher work in methods and/or academic subjects at the time of application.

That PI 3.03 (14) be amended to read:

PI 3.03 (14) SUBSTITUTE TEACHERS. Term certificates allowing persons to serve as substitute teachers in the public schools may be issued to applicants who have held or are eligible to hold a regular Wisconsin credential which has expired or the equivalent credential issued in another state.

That PI 3.04 (3) (a) be amended to read:

PI 3.04 (3) (a) <u>Life Certificates</u>. The unlimited or life certificate dated July 1, 1962 or thereafter, for all types of certification, will be valid so long as the holder remains active in the teaching profession. The credential shall become invalid if for 5 or more consecutive years the holder is not actively employed in a position in the teaching profession requiring the holding of a valid license. A person substituting for 90 days under a valid license shall be considered actively employed for that year. Such nullified credential may be renewed by presenting evidence of a minimum of 6 semester hours of refresher work in methods and/or academic subjects.

The rules contained herein shall take effect on the first day following publication in the Wisconsin Administrative Register.
