## ORDER OF THE CHIROPRACTIC EXAMINING BOARD ADOPTING RULES

Pursuant to the authority vested in the Chiropractic Examining Board by sections 15.08(5) and 446, Wis. Stats., and according to the procedure set forth in section 227.02(1)(b), Wis. Stats., the Chiropractic Examining Board hereby adopts the following rules:

Section Chir 1.05(5) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Chir 1.05(5) Pre-requisite to examination. A photostatic or photographic copy of a diploma from a chiropractic college approved by the examining board, size 8 1/2" x 11".

Section Chir 1.06 Fees of the WISCONSIN ADMINISTRATIVE CODE is repealed.

Section Chir 1.09 Licenses is amended to read:

Chir 1.09 Licenses. Licenses to practice chiropractic must be at all times conspicuously displayed in the office of the licensee. Biennial renewal cards shall be affixed to the license display.

Section Chir 3.08 of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Chir 3.08 Continuing Education Requirements for License Renewal. Each resident licensee shall submit to the board beginning December 31, 1977, and each year thereafter, satisfactory evidence that said licensee has attended within the calendar year, 12 hours of instruction in subjects relating to chiropractic and approved by the board. Said instruction must be under the supervision of college instructors, or the continuing education faculty of board approved chiropractic colleges, at a seminar given by the Wisconsin chiropractic association, chiropractic examining board, Chiropractic Association, International Chiropractic Association, or at a board-approved chiropractic college. Credits may be earned either from one session or accumulated from several sessions that calendar year. The board may, in its discretion, waive said educational requirements for the licensee by reason of an unusual emergency, extreme hardship or for other good and reasonable cause.
