As provided in Section 227.023, Wis. Stats., there is hereby submitted certified copies of sections H 77.11 and H 78.15 of Wisconsin Administrative Code Chapters H 77 and H 78, pertaining to licensing of mobile home parks, campgrounds and camping resorts, as adopted by the Secretary of the Department of Health & Social Services on November 29, 1977. In accordance with Section 227.018(3), Wis. Stats., the 30-day review by the appropriate legislative committee members expired on January 6, 1978, with no objections being raised.

These rules are being submitted to the Governor as required by Section 14.06, Wis. Stats., and to the Secretary of State as required by Section 227.023, Wis. Stats.

It is hoped that the rules can be published in the February 1978 edition of the Wisconsin Administrative Register and become effective on March 1, 1978.



ORDER OF THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES ADOPTING RULES

Pursuant to authority vested in the Department of Health and Social Services in Chapter 39, Laws of 1975, and in accordance with Chapter 227, Wis. Stats., the following rules are hereby promulgated.

Sections H 77.11 and H 78.15 of WISCONSIN ADMINISTRATIVE CODE Chapters H 77 and H 78 are created to read:

Section H 77.11, Wisconsin Administrative Code

License fees. (1) SCHEDULE. The annual nonreturnable and nonprorated fees for mobile home parks as defined in Section H 77.02 (5), Wisconsin Administrative Code for fiscal year 1977-78 are as follows:

Number of Sites	<u>Fee</u>
1-25	\$25.00
26-50	\$50.00
51-100	\$75.00
0ver 100	\$100.00

For fiscal year 1978-79 and thereafter, unless revised, the fees are as follows:

Number of Sites	<u>Fee</u>
1-25	\$10.00
26-50	\$20.00
51-100	\$30000
Over 100	\$40.00

- (2) EXPIRATION OF LICENSES. Licenses shall expire on June 30 of each license year commencing on June 30, 1978. An additional penalty fee of \$10.00 shall be required whenever the annual fee for renewal is not paid prior to the expiration of the license.
- (3) FEE REVISION. License fees may be increased in \$5.00 increments each year after fiscal year 1979-80 if necessary to support the program with the maximum of the graduated fee being \$100.00.

Section H 78.15, Wisconsin Administrative Code

License fees. (1) SCHEDULE. The annual nonreturnable and nonprorated fees for campgrounds and camping resorts as defined in Section H 78.02 (1), Wisconsin Administrative Code for fiscal year 1977-78 are as follows:

Number of Sites	Fee
1-25	\$25.00
26-50	\$50.00
51-100	\$75.00
Over 100	\$100.00

For fiscal year 1978-79 and thereafter, unless revised, the fees are as follows:

Number of Sites	<u>Fee</u>
1-25	\$10.00
26-50	\$20.00
51-100	\$30.00
Over 100	\$40.00

- (2) EXPIRATION OF LICENSES. Licenses shall expire on June 30 of each license year commencing on June 30, 1978. An additional penalty fee of \$10.00 shall be required whenever the annual fee for renewal is not paid prior to the expiration of the license.
- (3) FEE REVISION. License fees may be increased in \$5.00 increments each year after fiscal year 1979-80 if necessary to support the program with the maximum of the graduated fee being \$100.00

The rules contained herein shall take effect on March 1, 1978 as provided in Section 227.026(1), Wis. Stats., subject to the provisions of Section 14.06, Wis. Stats.
