ORDER OF THE DIRECTOR, STATE BUREAU OF PERSONNEL
REVISING RULES

Pursuant to authority vested in the Director of the State Bureau of Personnel by subsection 16.03(6) and Chapter 227, Wis. Stats., the Director of the State Bureau of Personnel hereby revises rules as follows:

Two sections of Chapter Pers 30, Wisconsin Administrative Code, Rules of the Director, are revised to read as stated on the material attached hereto.

The rules contained herein shall take effect on March 1, 1978, in accordance with section 227.026(1), Wis. Stats.

PROPOSED REVISION
OF THE
WISCONSIN ADMINISTRATIVE CODE
RULES OF THE DIRECTOR

Pers 30.99 intro. paragraph is amended to read:

Pers 30.99 Provisions regarding incumbents of positions placed in the career executive program upon initiation of the program, or by reallocation of a position into the program.

Pers 30.99(1) is repealed.

Pers 30.99(2) is renumbered and amended to read:

Pers 30.99(21) Each incumbent shall be given the option of being placed in the career executive program without certification in accordance with Wis. Adm. Code section Pers 30.05 or of remaining in his or her existing position under the non-career executive employment provisions. This option shall remain in effect for one year after the effective date of program implementation, or one year after the incumbent's position is placed in the program, whichever occurs later. A special 90-day open enrollment period shall be in effect beginning with the effective date of this rule revision. Within 30 days after the effective date of this revision all incumbents in career executive positions who did not exercise their option to enter the program shall be notified of the open enrollment period in writing and given the option to enter the program. Thereafter the employe remains in his or her existing position, which shall not be included in the career executive program as long as it is occupied by the incumbent under the non-career executive employment provisions and any subsequent entrance by the employe to the program shall be by competitive appointment under the provisions of Wis. Adm. Code section Pers 30.05.

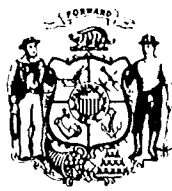

Dear Governor Schreiber:

Pursuant to ss. 16.03(6), 16.05(1)(c), and Chapter 227, Wisconsin Statutes, I am submitting for your consideration the proposed minor revisions of the Wisconsin Administrative Code, Rules of the Director, which have been developed to change the Career Executive Program by acknowledging that position incumbents may enter the Program by reallocation of their positions as well as by the original creation of the Program.

The proposed revision also acknowledges that the Executive Assessment Center was eliminated as a single mandatory examination for all Career Executive positions in June of 1976 and provides an open enrollment period of 90 days for those Career Executive incumbents who did not enter the Program during the initial one-year open enrollment period. This will give up to 23 Career Executive position incumbents the opportunity to enter the Program. Several agencies and position incumbents have expressed a desire for this open enrollment period so that management and position incumbents will have more flexibility for movement between positions. The revision relates only to filled positions and incumbents and has no affect on the number of vacant positions which can be filled by persons who are not currently at the level of Career Executive positions. The open enrollment period is necessitated by reorganization of several departments which has affected the status of a number of Career Executive positions and their incumbents.

In accordance with the law and upon proper notice to interested parties, the Deputy Director of the State Bureau of Personnel held a public hearing on these revisions on September 12, 1977. Agency representatives and interested persons were provided an opportunity to present their views and comments both at the public hearing and for submission to the State Bureau of Personnel following the hearing. The proposed revisions do not reflect substantive policy changes but are designed principally to reflect program changes resulting from agency reorganizations and elimination of the Executive Assessment Center.

The proposed revisions were considered by the State Personnel Board at its regular meeting on October 10, 1977, and unanimously approved by the members present. A copy of the State Personnel Board's communication to that effect is attached. In addition, copies of the proposed revisions have been submitted to the appropriate standing committees of the legislature for their consideration and review. Several appearances have also been made at the request of these legislative committees at their meetings to explain the proposed changes and their ramifications.

If you determine that these Rules should be approved, kindly endorse your signature thereon; and have your office advise the Department of Administration, State Bureau of Personnel, so that it may promptly make the certifications and transmittals required to continue the promulgation process for these Rules.
