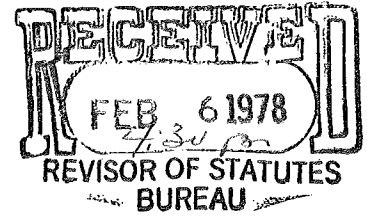

ORDER OF THE DEPARTMENT OF PUBLIC INSTRUCTION

ADOPTING RULES

This is an order of the State Superintendent of Public Instruction, adopting rule PI 3.20 (15) of the Wisconsin Administrative Code.

Pursuant to the authority vested in the Department of Public Instruction by Section 115.28 (7), Wisconsin Statutes, the State Superintendent of Public Instruction hereby adopts rule PI 3.20 (15) of the Wisconsin Administrative Code as follows:

That PI 3.20 (15) is renumbered to PI 3.20 (16).

That PI 3.20 (15) is created to read as follows:

PI 3.20 (15) Exceptional Education - Special Fields. Persons certified in physical education, music, art, home economics, industrial arts, and business education who have a specific assignment to teach exceptional children must hold certification in exceptional education if program reimbursement is to be approved.


(a) A regular three-year license may be issued upon verification that the applicant has completed the following:

1. Eligibility for a license in one of the special fields named above.
2. Nine semester credits of course work in:
  - a. Introduction or nature of exceptional children
  - b. Practicum in the particular area of specialization with exceptional children
  - c. Elective in special education

3. A statement from the institution at which the above course work was completed attesting to the competence of the applicant in the area of specialization with exceptional children.

That PI 3.20 (16) is renumbered to PI 3.20 (17).
