

## ORDER OF THE DEPARTMENT OF REGULATION AND LICENSING AMENDING AND REPEALING RULES

Pursuant to the authority vested in the Department of Regulation and Licensing by sections 15.08(5), Wis. Stats. and 449.17, as enacted in Chapter 280, Laws of 1977, the Department of Regulation and Licensing hereby repeals and amends rules as follows:

Section RL 10.01(2)(a) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

RL 10.01(2)(a) Refer patients who notify the optometrist of an adverse drug reaction to appropriate medical specialists or facilities;

Section RL 10.01(2)(c) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

Section RL 10.01(2)(c) Place in a patient's permanent record information describing any adverse drug reactions experienced by the patient and the date and time that any referral was made. Such plan shall include the names of at least three physicians, physician clinics or hospitals to whom the optometrist agrees to refer patients who experience an adverse drug reaction. At least one of these physicians shall be skilled in the diagnosis and treatment of diseases of the eye.

Section RL 10.01(5) of the WISCONSIN ADMINISTRATIVE CODE is amended to read:

RL 10.01(5) "Course of Study in Pharmacology" means a course of study completed in an approved institution after 1973 in general and clinical pharmacology as it relates to optometry with the characteristics described in Wis. Stats., s.449.17(4). For courses, such as continuing education courses, which do not lead to a degree in optometry to qualify as part of a course of study in pharmacology, the courses must include at least one examination on course content.

Section RL 10.01(9)(d) 2. of the WISCONSIN ADMINISTRATIVE CODE is repealed.

The amendments contained herein shall take effect on May 1, 1979.
