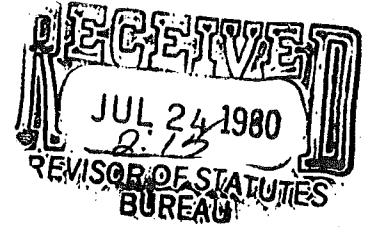




TO ALL TO WHOM THESE PRESENTS SHALL COME, GREETINGS:


ORDER OF ADOPTION
