ORDER OF THE DEPARTMENT OF HEALTH AND SOCIAL SERVICES AMENDING A RULE

Relating to alternates in the use of Silver Nitrate for gonococcal opthalmia in newborns.

ANAYLSIS BY THE DEPARTMENT OF HEALTH & SOCIAL SERVICES

The Department of Health and Social Services proposes that promulgation of a rule be undertaken to provide physicians and midwives with more than one effective regimen for prophylaxis of neonatal gonococcal ophthalmia in Wisconsin.

In 1979, the National Center for Disease Control in Atlanta, Georgia, a national as well as international authority on sexually transmitted diseases, revised their recommendations for the prevention of gonococcal ophthalmia in a newborn child to include not only silver nitrate, but also tetracycline and erythromycin ointment or drops.

By providing the attending physician or midwife with a choice of antibiotics for the prevention of gonococcal ophthalmia, they may more effectively meet the medical epidemiological, and philosophical needs of parents, newborns, and the community.

Pursuant to authority vested in the Department of Health and Social Services by s. 143.02(4), Stats., the Department of Health and Social Services is amending a rule interpreting ss. 143.01 and 143.02, stats., as follows:

SECTION H45.25(4) Wisconsin Administrative Code is amended to read:

H45.25(4) Prevention. The attending physician or midwife is required to place 2 drops of a one percent solution of silver nitrate, or 2 drops of a one percent ophthalmic solution of tetracycline or erythromycin, or a one centimeter strip of a one percent ophthalmic ointment of tetracycline or erythromycin, in each eye of a newborn child immediately as soon as possible, but not later than one hour after delivery. No more than one newborn child shall be treated from an individual container. Failure to observe this requirement is punishable by a fine of not more than one hundred dollars (s. 146.02, stats.).

The rules contained in this order shall take effect on the first day of the month following its publication in the Wisconsin Administrative Register as provided in section 227.026(1), stats.
