## ANALYSIS

The proposed rule, Opt. 7.05, interpreting s. 449.08, Wis. Stats., defines failure to specify certain information relating to prescription records in an optometric patient's case history as unprofessional conduct. The Optomerty Examining Board has found that in investigating allegations of unprofessional conduct, it is difficult to identify a particular optometrist because there is no requirement to specify the prescribing optometrist in a patient's case history. By requiring the name, license number, date of prescription and signature of a prescribing optometrist in a patient's case history, the board will better be able to identify licensees who violate standards of professional conduct.

#### ORDER

Now therefore it is ordered that pursuant to authority vested in the Optometry Examining Board in ss. 15.08(5), 227.014 and Chapter 449, Stats., the Optometry Examining Board hereby creates and adopts rules interpreting s. 449.08, Stats., as follows:

Section Opt 7.05 of the Wisconsin administrative code is created to read:

- 7.05 Prescription Record. It shall be considered unprofessional conduct not to include in each patient record the following information: (1) name of patient;
  - (2) date of prescription; and
  - (3) name, signature and license number of the examining optometrist.

The rule adoption contained in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026(1), Stats.,

Subject: Typographical Error on Optometry Board Rule Order

On August 12, 1980 I filed with your office a rulemaking order of the Optometry Examining Board, creating s. Opt 7.05 of the Wisconsin Administrative Code, relating to rules concerning standards for unprofessional conduct for optometrists.

It has been discovered that certain language that has been part of the required rulemaking procedures was inadvertently omitted when the final rulemaking order was prepared, signed and subsequently filed with the Revisor's office. A brief rulemaking history of s. Opt 7.05, Wis. Adm. Code, as adopted by the board, is as follows:

May 14, 1980 A 30-day Notice of the rule was submitted to the Revisor's office for publication in the Wisconsin Administrative Register. The Notice appeared in the May 1980 Register.

July 1, 1980 The proposed rule as it appeared in the Notice was referred to Senate Committee on Human Services and Assembly Committee on Health and Social Services in final draft form for 30-day legislative review.

August 2, 1980 The Optometry Examining Board approved and adopted the proposed rulemaking order as the final rulemaking order on s. Opt 7.05.

Attached is a stamped copy of the 30-day Notice that appeared in the May 1980 Register and a copy of the order with the omitted language inserted for your records. The board requests the correct provision be published in the code.



NOTICE IS HEREBY GIVEN That pursuant to sections 15.08(5), 227.014 and Chapter 449, Wis. Stats., and according to procedures set forth in section 227.02(1), Wis. Stats., the Optometry Examining Board will adopt the following rules interpreting section 449.08, Wis. Stats., created as herein proposed, without public hearing thereon unless, within 30 days after publication of this notice, it is petitioned for a public hearing on the proposed rules by 25 persons who will be affected by the rules, a municipality or an association which is representative of a farm, labor, business or professional group which will be affected by the rules:

Section Opt 7.05 of the Wisconsin administrative code is created to read:

7.05 Patient Record. It shall be unprofessional conduct not to include in each patient record the following information: (1) name and date of birth of patient;

- (2) date of examination; and
- (3) name, signature and license number of the examining optometrist.

Summary Analysis This new section of the code, interpreting section 449.08, Wis. Stats., is proposed to define failure to specify certain information relating to patient records in an optometric patient's case history as unprofessional conduct. The Optometry Examining Board has found that in investigating allegations of unprofessional conduct, it is difficult to identify a particular optometrist because there is no requirement to specify the prescribing optometrist in a patient's case history. By requiring name, signature and license number of a prescribing optometrist in a patient's case history, the board will better be able to identify licensees who violate standards of professional conduct.
