ORDER OF THE MEDICAL EXAMINING BOARD REPEALING, AMENDING OR ADOPTING RULES

ORDER

Now therefore it is ordered that pursuant to authority vested in the Medical Examining Board in ss. 15.08(5), 227.014 and Chapter 448, Stats., the Medical Examining Board hereby amends, repeals and recreates and adopts rules interpreting ss. 448.04(1)(e) and 448.13 of the statutes as follows:

- 1. Sections Med 7.02(20 and (3) of the Wisconsin Administrative Code are renumbered to ss. med 7.02(3) and (2) respectively and (3) as renumbered is amended to read:
- (3) Verified documentary evidence of graduation from a school of physical therapy approved by the boards.; The-board-recognizes-as-approved-these-schools-of-physical-therapy-recognized-and-approved-at-the-time-of-the-applicant's-graduation-therefrom-by-the-American-Physical-Therapy-Association-or-the-Gouncil-on-Medical-Education-of-the-American-Medical-Association,-or-successors.
- 2. Section Med 7.02(4) of the Wisconsin Administrative Code is created to read:
- (4) If an applicant has verified documentary evidence of graduation from a physical therapy school not approved by the board, the applicant must submit:
 - (a) A verified copy of transcripts from the schools from which secondary education was obtained;
 - (b) A verified copy of the diploma from the school at which professional physical therapy training was completed;
 - (c) A record of the number of class hours spent in each subject, for both pre-professional and professional courses. For subjects which include laboratory and discussion sectioons, the hours must be described in hours per lecture, hours per laboratory and hours per discussion per week. Information must include whether subjects have been taken at basic entry or advanced levels; and
 - (d) A syllabus which describes the material covered in each subject completed.

The board shall determine whether the applicant's educational training is equivalent to that specified in s. Med 7.02(3), Wis. Adm. Code. In lieu of its own evaluation, the board may use, as it deems appropriate, evaluations prepared by the University of Wisconsin-Madison. The cost of an evaluation shall be paid by the applicant.

NOTE: The board approves those schools of physical therapy that are at the time of the applicant's graduation recognized and approved by the American Physical Therapy Association or the Council on Medical Education of the American Medical Association, or their successors.

- 3. Section Med 7.08(1) of the Wisconsin Administrative Code is amended to read:
- (1) An applicant for regular license to practice physical therapy who is a graduate of an approved school of physical therapy in-this-state may also apply to the board for a temporary license to practice physical therapy under supervision. The application for such temporary license shall be made not less than 60 30 days and not more than 150 days prior to the date set by the board for the holding of its next examinations for regular license to practice physical therapy. The applications and required documents for regular license and for such temporary license will be reviewed by an officer of the physical therapy examining council, and upon the finding by such officer that the applicant is qualified for admission to examination for regular license to practice physical therapy, the board, acting through such officer, may issue a temporary license to practice physical therapy under supervision to such applicant.
- 4. Section Med 13.02(1) of the Wisconsin Administrative Code is amended to read:
- (1) Each physician required to complete the biennial training requirement provided under s. 448.13, Stats., shall, in each second year at the time of making application for a certificate of registration as required under s. 448.07, Stats., have-submitted-to-the-board-proof-of-attendance-at-and-completion-of sign a statement on the application for registration certifying that the physician has completed at least 30 hours of acceptable continuing medical educational programs within the 2 calendar years immediately proceding the calendar year for which application for registration is made.
- 5. Section Med 13.03 of the Wisconsin Administrative Code is amended to read:
- 13.03 Acceptable continuing medical educational programs; hours. Only courses and programs approved in advance by the board may be used for credit, except that the board may approve for credit completed programs and courses conducted in other countries. The board recognizes only those programs recognized as approved at the time of the physician's attendance by the Council on Medical Education of the American Medical Association, or the American Osteopathic Association, or the Liaison Committee on Continuing Medical Education or may recognize program providers outside the U.S. unless any of the foregoing have been previously

disapproved by the board. The board will accept attendance at and completion of programs accredited as the American Medical Association's or the American Osteopathic Association's "Category I" or an equivalent as fulfilling the requirements of this chapter for continuing medical education. One clock hour of such attendance shall be deemed to equal one hour of acceptable continuing medical education for the purposes of this chapter.

- 6. Section Med 13.05 (title) and (1) of the Wisconsin Administrative Code is amended to read:
- 13.05 (title) Proof-of-compliance; timely-submission. Evidence of compliance. (1) The board will accept as proof evidence of compliance with the requirements of this chapter the-submission, as original documents or verified copies thereof, of any or all or any combination of the following:
- 6. Section Med 13.05(2) of the Wisconsin Administrative Code is repealed and recreated to read:
- (2) Evidence of compliance shall be retained by each physician through the biennium for which 30 hours of credit are required for registration.
- 8. Section Med 13.06 of the Wisconsin Administrative Code is created to read:
- 13.06 Audit. The board may require any physician to submit his or her evidence of compliance to the board during the biennium for which 30 hours of credit are required for registration to audit compliance.

The rule amendments, repeals and recreations and adoptions contained in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026(1), Wis. Stats.
