ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING AND REPEALING AND RECREATING RULES

Analysis Prepared by the Department of Natural Resources

The rule changes in this order are the result of statutory provisions enacted by the 1979 legislature (Chapter 274, Laws of 1979) relating to emission limitations and air pollution control equipment for motor vehicles.

Section 1 conforms the current provisions of the administrative code prohibiting tampering with air pollution control equipment for motor vehicles with the statutory provisions on tampering enacted in the 1979 legislative session (section 144.42(6), Wis. Stats.).

Section 2 promulgates emission limitations which must be met by motor vehicles which are required to be inspected under the emission inspection and maintenance program established under section 110.20, Wis. Stats. The emission limitations, which the department is required to adopt under section 144.42(2), Wis. Stats., are expressed in terms of maximum concentrations of carbon monoxide and hydrocarbons in the exhaust. The emission limitations are applicable to all motor vehicles which are registered in Racine, Kenosha, Waukesha, Milwaukee, Washington and Ozaukee counties unless the motor vehicles are exempt from the emission limitations. Section 2 also includes several categories of motor vehicles which are exempt from the emission limitations. These categories are in addition to the exempt motor vehicles listed in section 144.42(5), Wis. Stats.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 144.31(1)(a), 144.42(2), (5) and (6) and 227.014(2), Stats., the State of Wisconsin Natural Resources Board hereby adopts rules

interpreting s. 144.42(2), (5) and (6), Stats., and revising the State Implementation Plan developed under s. 144.31(1)(f), Stats., as follows:

SECTION 1. NR 154.17(2)(intro.) is amended to read:

(2) (intro.) TAMPERING WITH AIR POLLUTION CONTROL EQUIPMENT. No person shall-eause,-suffer,-allow,-or-permit-the-removal,-dismantling,-disconnection, disabling,-or-disrepair-of may dismantle, remove, or cause to be inoperative any air pollution control device or system which has been installed on a motor vehicle or-internal-combustion-engine unless the person replaces the device or system with an identical or comparable tested replacement device or system.

SECTION 2. NR 154.17(3) is repealed and recreated to read:

- (3) MOTOR VEHICLE EMISSION LIMITATIONS; EXEMPTIONS.
- (a) Any motor vehicle which is subject to inspection under s. 110.20(6), Stats., may not emit carbon monoxide (CO) or hydrocarbons (HC) from the exhaust system in concentrations greater than those set forth in Table 1 when measured in an inspection conducted under ch. Trans. 131.

Note: Chapter Trans. 131 is being adopted by the Department of Transportation and promulgation of the rule is expected by March 1, 1983. Copies of ch. Trans. 131 may be obtained from the Department of Transportation, Division of Motor Vehicles, Room 255, Hill Farms State Office Building, 4802 Sheboygan Avenue, Madison, Wisconsin 53702.

- (b) In addition to the vehicles specified in s. 144.42(5), Stats., the following motor vehicles are exempt from the emission limitations of par. (a):
 - 1. A motor carrier used "for hire" as defined in s. 194.01(15), Stats.
 - 2. A truck tractor as defined in s. 340.01(73), Stats.
 - 3. A motor home as defined in s. 340.01(33m), Stats.
- 4. A motor vehicle registered under s. 341.26(2)(b), (d), (dm), (e),(f), (g), (h), (i), (j), (k) or (m), (2r) or (4), Stats.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on October 27, 1982.

The rules contained herein shall take effect as provided in s. 227.026(1)(intro.), Stats.
