ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD RENUMBERING, AMENDING, AND CREATING RULES

Analysis Prepared by the Department of Natural Resources

Section NR 25.06(2)(a)3., Wis. Adm. Code, is renumbered to make room for created s. NR 25.06(2)(a)3.

The amendment to s. NR 25.06(2)(a)1., Wis. Adm. Code, increased the total allowable annual commercial chub harvest from 1,650,000 to 2,500,000 pounds.

The amending of s. NR 25.06(3)(f), Wis. Adm. Code, makes it illegal to possess or use fish tags which have been modified or tampered with.

Creating s. NR 25.06(2)(a)3., Wis. Adm. Code, specifies the amount of the total allowable annual commercial chub harvest that may be taken in the southern chub fishing zone.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 29.085, 29.174, 29.33 and 227.014, Stats., the State of Wisconsin Natural Resources Board hereby renumbers, amends, and creates rules interpreting ss. 29.085, 29.174 and 29.33, Stats., as follows:

Section 1. NR 25.06(2)(a)1. is amended to read:

1. The total allowable commercial harvest for any license year may not exceed $\frac{1}{5}650$,000 $\frac{2}{500}$,000 pounds, not including incidental catches allowed elsewhere in this chapter.

Section 2. NR 25.06(2)(a)3. is renumbered 25.06(2)(a)4.

Section 3. NR 25.06(2)(a)3. is created to read:

3. No more than 2,100,000 pounds of the total allowable commercial harvest for any license year may be taken in the southern chub fishing zone.

Section 4. NR 25.06(3)(f) is amended to read:

(f) Fags No person may possess or use tags furnished or authorized by the department for tagging fish may-net-be which have been modified or tampered with.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on February 23, 1983.

The rules contained herein shall take effect as provided in s. 227.026(1)(intro.), Stats.
