#### ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD AMENDING, REPEALING AND RECREATING, AND CREATING RULES

IN THE MATTER of amending s. NR 46.09(1)(d); repealing and recreating s. NR 46.09(2)(a), (b) . and (c); and creating s. NR 46.02 (15m) and (24m). Fo-15-83 of the Wisconsin Administrative Code pertaining . to the Woodland Tax Law and stumpage values for . severance tax under the Forest Crop Law .

#### Analysis Prepared by Department of Natural Resources

- Creates a definition of the terms "open area" and "understocked area" to aid in implementing mandatory management plan practices permitted under NR 46.10(1)(e)4.d., the reforestation of open and understocked areas. Presently no precise definition of these terms exists, hence making it very difficult to apply mandatory practices on open and understocked areas.
- 2. Amends the criteria for eligibility for catastrophic reduction on severance tax to require involvement of "30% of the merchantable timber on 10 or more contiguous acres". Present wording permits approval of small non-contiguous areas totaling 20 acres involving a relatively small proportion of the merchantable stands. Such situations are in fact not of catastrophic nature and are difficult to assess in terms of value loss to the owner.
- 3. Create annual stumpage values for the purpose of calculating severance tax due on timber cut from Forest Crop Law lands as of November 1, 1983, as required by s. 77.06(2), Stats. There are five separate severance schedule zones reflecting varying stumpage prices for different species and products across the state. This makes it possible to levy severance taxes which more nearly represent 10% of the actual stumpage value which is the basic legislative intent.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 77.06(2), 77.16 and 227.014, Stats., the State of Wisconsin Natural Resources Board hereby amends, repeals and recreates, and creates rules interpreting ss. 77.06(2) and 77.16, Stats., as follows:

SECTION 1. NR 46.02 (15m) and (24m) are created to read:

(15m) "Open areas" means nonproductive areas capable of producing merchantable timber when stocked with suitable forest trees.

SECTION 3. NR 46.09(2)(a), (b) and (c) are repealed and recreated to read:

(2) STUMPAGE VALUES FOR SEVERANCE TAX. Forest crop law severance schedule zones are established as designated on the map of the forest crop law severance schedule zones in par. (d) and the rates shall be as follows:
