ADOPTING RULES

A RULE to repeal and recreate FDE 2.02 and create FDE 2.135, relating to rules concerning examination scores and apprenticeship credit.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

In this proposal:

- 1. Section FDE 2.02, interpreting ss. 445.04(3) and 445.05(4), Stats., which relate to the Funeral Directors and Embalmers Examining Board's requirements for examination, is repealed and recreated to indicate that the passing score of the board examination shall be based on the board's determination of minimum acceptable competency in professional practice rather than by a fixed percentage score, as in the current rule.
- 2. Section FDE 2.135, interpreting s. 445.10, Stats., which relate to funeral director and embalmer apprenticeship requirements, is created to specify in rule a Funeral Directors and Embalmers Examining Board policy that credit toward the term of apprenticeship is granted for a period of employment of no less than 40 hours in each of two consecutive weeks, unless an apprentice requests and the board approves credit for a shorter period of time.

ORDER

Pursuant to authority vested in the Funeral Directors & Embalmers Examining Board in ss. 15.08(5), 227.014 and 445.03(2)(a), Stats., the Funeral Directors & Embalmers Examining Board hereby repeals and recreates, creates and adopts rules, interpreting ss. 445.04(3), 445.05(4) and 445.10, Stats., as follows:

SECTION 1. FDE 2.02 is repealed and recreated to read:

FDE 2.02 EXAMINATION SCORE. The score required to pass the examination shall be based on the funeral directors and embalmers examining board's determination of the level of examination performance required for minimum acceptable competency in the profession. The passing score shall be established prior to administration of the examination and shall be designated by a grade of 75.

SECTION 2. FDE 2.135 is created to read:

FDE 2.135 APPRENTICESHIP CREDIT. An apprentice certified under s. 445.095(1), Stats., shall be granted credit toward the term of his or her apprenticeship for a period of employment of no less than 40 hours in each of 2 consecutive weeks. However, credit for a shorter period of employment may be approved if an apprentice submits evidence satisfactory to the board that an exception be made.

The rules repealed and recreated, created and adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.026, Stats.
