ORDER OF THE STATE OF WISCONSIN
NATURAL RESOURCES BOARD
CREATING RULES

IN THE MATTER of creating s. NR 154.13(13)(bm) of
the Wisconsin Administrative Code pertaining to
the use of the internal offset for compliance with
VOC emission limits for certain relocated sources

Analysis Prepared by Department of Natural Resources

Under existing rules (s. NR 154.13(13)(b), Wis. Adm. Code), the owner or operator of a surface coating or printing facility constructed or modified before a certain date (August 1, 1979 or April 1, 1981) may comply with emission limits for volatile organic compounds (VOCs) through an approved compliance plan which authorizes internal offsets or a bubble for VOC emissions from coating or printing lines in the facility. The internal offset compliance method is not available to coating or printing lines constructed or modified after the specified dates, including existing lines which are relocated to other facilities after those dates.

The proposed rule, issued pursuant to ss. 144.31, 44.38 and 227.014(2)(a), Stats., authorizes the use of the internal offset method of compliance with VOC emission limits for coating or printing lines which are relocated to another facility.

Under the proposed rule, the use of the internal offset compliance method for relocated lines would be restricted to coating or printing lines which had been jointly involved in a previously approved internal offset.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ss. 144.31, 144.38 and 227.014(2)(a), Stats., the State of Wisconsin Natural Resources Board hereby creates rules interpreting s. 144.31(1)(f), Stats., and revising the State Implementation Plan (SIP) developed under that provision as follows:

SECTION 1. NR 154.13(13)(bm) is created to read:

NR 154.13(13)(bm) Internal offsets for relocated lines. Notwithstanding par. (b)1.b., any coating or printing line which is relocated to another facility may comply with the emission limitations in this section through an internal offset if:

1. The internal offset applies only to relocated coating or printing lines which had been jointly involved in an internal offset approved under par. (b)2.; and

2. The internal offset involving the relocated lines is approved by the department under the criteria of par. (b)1.a., c. and d.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on January 23, 1985.

The rules herein shall take effect as provided in s. 227.026(1)(intro.), Stats.

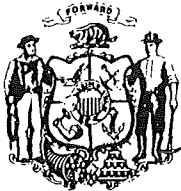


