ANALYSIS PREPARED BY DEPARTMENT OF NATURAL RESOURCES

In 1971, 1979 and 1983 the state legislature enacted air pollution control legislation which required the department to promulgate certain administrative rules to fully implement the State Air Pollution Control Program. The air rules were originally enacted as chs. NR 154 and 155. As the regulation of sources of air pollution expanded, the administrative rules containing regulatory provisions increased in complexity and length. The department determined in 1983 that the NR 400 series of the Wisconsin Administrative Code would be reserved for air pollution control rules. Chapters NR 404, 407, 410, 440, and 493 have since been adopted to accommodate the expanding air pollution control program. The rules contained in this order reorganize, clarify, and add continuity to the requirements imposed on sources regulated under the Air Pollution Control Program.

The goal of this rule reorganization is two-fold: to simplify the compliance efforts of sources regulated under the Air Pollution Control Program and to streamline the administration and enforcement efforts of the department. The new rules incorporated provisions of chs. NR 154, 404, 407, 410, and 493 and separate each distinct regulatory area into an individual chapter. This improves everyone's understanding of the requirements of the Air Pollution Control Program and how the program is designed to work.

Pursuant to the authority vested in the State of Wisconsin Natural Resources Board by ch. 144 subchapter III, Stats., the State of Wisconsin Natural Resources Board hereby repeals, renames, amends and creates rules implementing Wisconsin's Air Pollution Control Program and revises the State Implementation Plan (SIP) developed under s. 144.31(1)(f), Stats., as follows:
