

ORDER OF THE WISCONSIN NATURAL RESOURCES BOARD REPEALING, AMENDING, REPEALING AND RECREATING, AND CREATING RULES

IN THE MATTER of repealing ss. NR 10.01(1)(q) and (r), . 10.19 and 15.01(14); amending ss. NR 16.02(1), . 17.02(3)(b) and 17.02(4)(b); repealing and recreating . ss. NR 10.01(4)(c), 10.27 and 18.04; and creating . WM-1-87 ss. NR 1.11, 10.05(1) and (2), 10.06(1), 10.06(2)(a) . to (d), 10.06(3) to (6) and 10.12(3)(a) to (e) . (titles) and 11.08(1)(b) pertaining to housekeeping . modifications to hunting, closed area, refuge and . falconry regulations.

Analysis Prepared by Department of Natural Resources

The rules are promulgated under the authority of ss. 29.174(2)(a) and 227.16(2)(e), Stats., and interpret 29.57(1).

- 1. Titles are created for quick reference purposes.
- 2. Beaver seasons are expanded to reduce statewide damage problems.
- 3. Duplication of deer transportation restrictions is eliminated.
- 4. MVP Canada goose hunting permit procedures are eliminated. A new Department survey method makes the MVP permit unnecessary.
- 5. Cross references to statutes are updated, punctuation corrected and dog training firearm use is clarified.
- 6. Firearm and bow deer hunting is created for Plum Island (part of Grand Traverse Islands State Park) as part of an agreement with the U.S. Coast Guard who are responsible for the island.
- 7. Sharp-tailed grouse hunting is closed on 640 acres in Burnett county to enhance production in a local population.
- 8. A private refuge no longer meeting law requirements in Portage county is eliminated with the owner's consent.
- 9. The status of protected animals accidentally killed in falconry is clarified.

SECTION 5. NR 10.27 is repealed and recreated to read:

<u>NR 10.27 STATE PARK DEER HUNTING</u>. No person may hunt deer on state parks and recreation land except as provided in this section. Portions of the properties listed may be posted closed to deer hunting. (1) MUZZLE-LOADER SEASON. Deer hunting by muzzle-loader is allowed in Blue Mound, Governor Dodge and Perrot state parks during the seasons specified in s. NR 10.01(3)(e)3.

(2) FIREARM SEASON. Deer hunting by firearm is allowed in Natural Bridge and Wyalusing state parks during the season specified in s. NR 10.01(3)(e)1.d.

(3) EARLY BOW SEASON. Deer hunting by bow and arrow through November is allowed in Buckhorn state park as specified in s. NR 10.01(3)(em).


(4) FIREARM AND BOW SEASONS. Deer hunting by firearm and bow and arrow is allowed in the Plum Island part of Grand Traverse Islands state park during the seasons specified in s. NR 10.01(3)(e)1.d. and (em).

(5) FIREARM AND LATE BOW SEASONS. Deer hunting by firearm and bow and arrow is established by s. NR 10.01(3)(e)1.d and the December portion of NR 10.01(3)(em) for the following:

(a) Big Bay state park Devil's Lake state park (b) Elroy-Sparta state trail (c) Hartman Creek state park (d) (e) Interstate state park Kinnickinnic state park (f) Mirror Lake state park (g) Newport state park (h) Rock Island state park (i) Tuscobia-Park Falls state trail (j) (k) Wildcat Mountain state park (1) Willow River state park

SECTION 6. NR 11.08(1)(b) is created to read:

NR 11.08(1)(b) <u>Namekagon barrons</u>. Township 42 north, Range 14 west, town of Blaine (east).



SECTION 7. NR 15.01(14) is repealed.

SECTION 8. NR 16.02(1), 17.02(3)(b) and 17.02(4)(b)(intro.) are amended to read:

NR 16.02(1) APPLICATION. This section applies to all game farms as provided in s. 29.574, Stats., including commercial operations, shooting game farms and hobbyists. The owner or lessee of any lands within the state suitable for the breeding and propagating of game birds or animals as may-be approved by the department shall have the right upon complying with this section, to establish, operate and maintain a game bird and animal farm for the purpose of breeding, propagating, killing and selling game birds and game animals on such lands. On areas where the hunting or killing of wild animals is to be permitted, the game farm license shall only include species listed in s. $29 \cdot 01(3)(b) \cdot -(c) - and -(d) 29.01(4)$, (6) and (7), Stats.

NR 17.02(3)(b) <u>Licensed animals</u>. Training hunting dogs with raccoons possessed under authority of a game <u>or</u> fur farm license may be used at any time outside of department lands without a permit provided the animals are kept under control by caging or similar restraint. Except for bear dog training, training hunting dogs on other protected game possessed under the authority of a game farm, fur farm or shooting preserve license may also be used at any time outside of department lands without permit.

NR 17.02(4)(b) <u>Firearms</u>. (intro.) Firearms-ineluding-blank <u>Blank</u> handguns may be used for dog training on wild game without a permit. Special firearm restrictions include:

SECTION 9. NR 18.04 is repealed and recreated to read.

<u>NR 18.04 FALCONRY HUNTING</u>. (1) ESTABLISHED SEASONS. In addition to the seasons established by ch. NR 10, falconry permit holders may hunt upland game birds and animals described in s. NR 10.01(2) and (3) September 1 through March 31, except cottontail rabbit, fox squirrel and gray squirrel may be hunted year-round.

(2) LET LAY RULE. A falconry permit holder whose raptor accidentally kills any protected animal during the closed season or a protected animal or sex during the open hunting season shall leave the dead animal where it lies. The raptor may feed upon the dead animal prior to leaving the kill site.

Note: Daily kill and possession limits, hunting hours and other rules established for hunting by chs. 10, 11 and 15 and ch. 29, Stats., apply.

The foregoing rules were approved and adopted by the State of Wisconsin Natural Resources Board on January 29, 1987.

The rules shall take effect as provided in s. 227.22(2)(intro.), Stats. Dated at Madison, Wisconsin May 20, 1987
