## ORDER

AN ORDER to repeal C 6.02 to 6.04 and, repeal and recreate C 6.01, relating to denial of license.

Analysis prepared by the department of regulation and licensing.

## ANALYSIS

Under authority in s. 440.03(1), Stats., the department of regulation and licensing proposed rules in clearinghouse rule 84-223 which establish uniform procedures for the conduct of a hearing on a denial of license before the department or any examining board attached to the department.

In this order, s. C 6.01 is repealed and recreated to indicate that rules on procedure on a denial of license are specified in ch. RL 1 and ss. C 6.02 to 6.04 are repealed to eliminate duplication of rules and procedures in license denial proceedings.

The rules proposed by the department in clearinghouse rule 84-223 became effective on November 1, 1985.

The rules proposed for revision in ch. C 6 interpret s. 227.44, Stats., relating to contested cases, notice, hearing and records and s. 458.08, Stats., relating to licensing requirements.

## TEXT OF RULE

Pursuant to authority vested in the cosmetology examining board in ss. 15.08(5)(b), 227.11, 458.03(1), Stats., the cosmetology examining board hereby repeals and recreates rules, interpreting ss. 227.44, and 458.08, Stats., as follows:

SECTION 1. C 6.01 is repealed and recreated to read:

C 6.01 DENIAL OF LICENSE. Rules of procedure on denial of license are specified in ch. RL 1.

SECTION 2. C 6.02 to 6.04 are repealed.

The rules revised in this order shall take effect on the first day of the

month following publication in the Wisconsin administrative register, pursuant to s. 227.22(2), Stats.
