## ORDER OF THE STATE OF WISCONSIN

- DEPARTMENT OF AGRICULTURE, TRADE AND CONSUMER PROTECTION

ADOPTING, AMENDING OR REPEALING RULES

- 1 Relating to rules concerning restrictions on cattle and
- 2 American bison imported into this state from brucellosis class "B"
- 3 or "C" states.

## Analysis Prepared by the Department of Agriculture, Trade and Consumer Protection

The importation and movement of animals is regulated by the Department of Agriculture, Trade and Consumer Protection in order to protect the animal industry in this state from communicable diseases of bovine and other animals. Rules adopted to accomplish this objective are located in Chapter Ag 10, Wis. Adm. Code. Brucellosis is a highly contagious and infectious bacterial disease of cattle and American bison. In these animals it causes abortion, reproductive failure and loss of productivity. Current regulations require a brucellosis vaccination, with certain exceptions, for cattle imported into this state. The exemptions apply primarily to breeding stock in which vaccination at an early age is ineffective. Unless imported animals of breeding stock age originate from a certified brucellosis-free herd or area, additional restrictions or import requirements are necessary.

The animal and plant health inspection service of the U.S. Department of Agriculture ("federal bureau") classifies entire states or smaller geographic areas within a state as certified brucellosis-free, class "A," "B," or "C" areas. The amendment to s. Ag 10.02(1) authorizes the department to deny importation of cattle originating from a brucellosis class B or C state unless the cattle are either spayed, castrated, "F" branded (signifying "feeder" cattle) and shipped to a feedlot, or originate from a certified brucellosis-free herd. The new requirements will greatly reduce the chances of introducing brucellosis into Wisconsin from out-of-state sources and better enable this state to maintain its status as a certified brucellosis-free state.

A further technical amendment is also proposed. Section Ag 10.02(1)(a)5 was created effective 7-1-83, and later repealed effective 6-1-85. At the time of repeal, a cross-reference to par. (a)(5) in par. (c)3 was inadvertently omitted from the repeal. Since the new brucellosis import requirements create a new par. (a)5, the obsolete cross-reference is deleted.

- 11 this state unless premovement authorization for entry has been
- 12 granted by the department and the animals are accompanied by
- 13 a certificate of veterinary inspection or an interstate health
- 14 certificate. The department shall grant or deny premovement
- 15 authorization within 5 business days after a request for
- 16 premovement authorization has been made to the department, provided
- 17 that the request is accompanied by all requisite information and
- 18 documentation. The department may deny premovement authorization
- 19 and import of cattle or American bison into this state if the
- 20 animals originate from any state classified by the federal bureau
- 21 as a brucellosis B or C state unless the cattle are spayed,
- 22 castrated, "F" branded and shipped directly to an approved feedlot,
- 23 or originate from a certified brucellosis-free herd.
- SECTION 3. Ag 10.02(1)(a)5 is created to read:
- As 10.02(1)(a)(5). The conditions which qualify animals
- 26 originating from a brucellosis B or C state for importation into

2	SECTION 4. Ag 10.02(1)(c)3 is amended to read:
3	(c) 3. Animals shipped for exhibition only if the animals
4	are accompanied by an interstate health certificate which includes
5	thereon a report of a negative brucellosis, tuberculosis and
6	anaplasmosis test conducted within 90 days of exhibitiion (and the
7	statement required under par. (a)5.).
8	SECTION 5. The rules contained in this order shall take
