ORDER

AN ORDER to amend DE 2.01(1)(e), and to create DE 5.02(24) and (25), relating to evaluation of foreign dental education and unprofessional conduct.

Analysis prepared by the department of regulation and licensing.

ANALYSIS

Statutory authority: ss. 15.08(5)(b), 227.11(2)(a), Stats. Statute interpreted: ss. 447.03(1), 447.07(3)(a), Stats.

In this order the dentistry examining board eliminates references to specific states' foreign graduate evaluation programs, some of which no longer exist, and refers instead to a broader description of "board-approved foreign graduate evaluation program". This will provide the board more flexibility in approving programs such as a Wisconsin program which now exists.

Under s. DE 5.02(24), the dentistry examining board makes it unprofessional conduct for a dentist or dental hygienist to fail to maintain CPR certification so as to be able to render lifesaving measures during an emergency in the dental office.

Finally, the board requires, under s. DE 5.02(25), that licensees cooperate in a timely manner with any investigation of complaints filed against them.

TEXT OF RULE

SECTION 1. DE 2.01(1)(e) is amended to read:

DE 2.01(1)(e) Evidence satisfactory to the board of having completed educational requirements in s. 447.03(2), Stats. In the case of a graduate of a foreign dental school, verification shall be provided from a board-approved foreign graduate evaluation program eendueted-in-Galifernia,-Maryland,-Minneseta,-New-Yerk-and-ether-beard-approved-evaluation-programs of successful completion of the evaluation course;

SECTION 2. Section DE 5.02(24) and (25) are created to read:

DE 5.02(24) Failing to hold a current certificate in cardiopulmonary resuscitation unless the licensee has obtained a waiver from the board based on a medical evaluation documenting physical inability to comply. A waiver shall be issued by the Board only if it is satisfied that another person with current certification in CPR is immediately available to the licensee when patients are present.

(2) After a request by the board, failing to cooperate in a timely manner with the board's investigation of complaints filed against the applicant or licensee. There is a rebuttable presumption that a licensee or applicant who takes longer than 30 days to respond to a request of the board has not acted in a timely manner under this subsection.

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.22(2) (intro), Stats.
