ORDER OF THE COMMISSIONER OF INSURANCE REPEALING, RENUMBERING, RENUMBERING AND AMENDING,

AMENDING AND CREATING A RULE

To repeal Ins 6.66 (5) (title) and (6); renumber Ins 6.66 (1), (2), and (3); renumber and amend Ins 6.66 (7); amend Ins 6.66 (title); and create Ins 6.66 (1) relating to eliminating reference to intermediary-brokers.

ANALYSIS PREPARED BY THE COMMISSIONER OF INSURANCE

Statutory authority: s. 601.41 (3), Stats.

Statute interpreted: s. 628.61, Stats.

The purpose of this rule is to remove references to intermediary-brokers in Ins 6.66. A handful of agents occasionally use the distinction made in Ins 6.66 between agents and brokers to proclaim themselves to be brokers. They then claim that they are not subject to any statute or rule governing agents. Since these laws are meant to protect Wisconsin's insurance consumers, this practice should be discouraged. Eliminating the distinction made between agents and brokers in Ins 6.66 will discourage the practice of agents proclaiming themselves to be brokers.

SECTION 1. Ins 6.66 (title) is amended to read:

Ins 6.66 (title) PROPER EXCHANGE OF BUSINESS.

SECTION 2. Ins 6.66 (1) is renumbered Ins 6.66 (2).

SECTION 3. Ins 6.66 (1) is created to read:

Ins 6.66 (1) The purpose of this rule is to interpret s. 628.61, Stats., regarding the proper exchange of business between agent intermediaries.

SECTION 4. Ins 6.66 (2) and (3) are renumbered Ins 6.66 (3) and (4).

Ins 6.66 (5) (title) and (6) are repealed. SECTION 5.

SECTION 6. Ins 6.66 (7) is renumbered Ins 6.66 (6) and, as renumbered, amended to read:

Ins 6.66 (6) The exchange of business among intermediary-brokers intermediary-agents and participation by intermediaries in risk sharing plans approved according to ch. 619, Stats., shall not be limited in any way by this section.

EFFECTIVE DATE. Pursuant to s. 227.22 (2), Stats., this rule shall first apply on the first day of the month commencing after the date of publication.
