IN THE MATTER OF creating s. NR 128.05(5)(w) . of the Wisconsin Administrative Code pertaining . to the ineligibility of costs incurred in . contracts which create an appearance of a . conflict of interest.

Analysis Prepared by Department of Natural Resources

Authorizing statutes: ss. 144.24(2), 144.242(3) and 227.11(2)(a), Stats. Statutes interpreted: s. 144.24(2) and 144.242(3), Stats.

The proposed addition to s. NR 128.05(5) will identify situations where a conflict of interest may exist and clarify the department's position regarding such conflicts of interest.

SECTION 1. NR 128.05(5)(w) is created to read:

NR 128.05(5)(w) Costs incurred in a contract which creates a real or apparent conflict of interest. An apparent conflict of interest arises when an official or employe of a grantee participates in the selection, awarding or administration of a contract supported by the Wisconsin fund and:

1. The official or employe, the official or employe's spouse or offspring, or the official or employe's partner has a financial interest in the firm selected for the contract; or

2. Any person identified in subd. 1 receives any benefit from the award of the contract, including but not limited to, gratuities, favors and award of any subcontract. The foregoing rule was approved and adopted by the State of Wisconsin Natural Resources Board on <u>May 26, 1988</u>.

The rule shall take effect the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.
