Analysis Prepared by the Department of Natural Resources

Statutory authority: ss. 144.31(1)(a), 144.38 and 227.11(2)(a) Stats.

Statutes interpreted: ss. 144.31(1)(f) and 144.38, Stats., and revise the State Implementation Plan (SIP) developed under s. 144.31(1)(f), Stats.

Under current air management administrative rules, volatile organic compound (VOC) emissions resulting from metal parts silk screening process lines are regulated by s. NR 422.15, Wis. Adm. Code. This provision subjects VOC emissions from such process lines to Reasonably Available Control Technology (RACT) emission limitations for miscellaneous metal parts and products. Information presented to air management staff by Northern Engraving Corporation, Sparta, and information obtained by staff through conducting a nationwide survey indicates that the RACT limitations as they apply to metal parts silk screening process lines are infeasible.

It has been shown that low VOC metal parts silk screening inks which would entirely meet the RACT limitations are currently unavailable to end users such as Northern Engraving, and that add-on control options for metal parts silk screening process lines with relatively small VOC emissions are economically infeasible.

The proposed revisions will exempt metal parts silk screening VOC emissions from RACT level emission requirements. VOC emissions from such process lines will instead be covered under more general emission limitations in Chapter NR 424, Wis. Adm. Code. In addition, an obsolete requirement, s. NR 424.03(2)(b), Wis. Adm. Code, is proposed to be repealed.

SECTION 3. NR 422.15(1)(j) is created to read:

NR 422.15(1)(j) Silk screening of metal parts and products.

SECTION 4. NR 424.03(2)(b) is repealed.

SECTION 5. NR 424.03(2)(c) is renumbered NR 424.03(2)(b), and (2)(b) (intro.), as renumbered, is amended to read:

NR 424.03(2)(b) Process lines on which construction or modification commenced on or after April 1, 1981, August 1, 1979, and which are not subject to emission limitations listed elsewhere in chs. NR 419 to 423 shall:

The rules shall take effect the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2) (intro.), Stats.

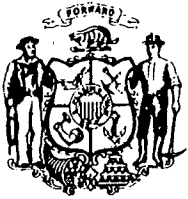
