# ORDER OF THE STATE OF WISCONSIN NATURAL RESOURCES BOARD REPEALING RULES

IN THE MATTER of repealing s. NR 104.07(3) . of the Wisconsin Administrative Code . pertaining to a revised surface water . WR-37-89 quality criterion for a segment of the . Oconto River .

#### Analysis Prepared by Department of Natural Resources

Statutory authority: ss. 144.025(2)(b), 227.11(2)(a) and 227.16(2)(e), Stats. Statutes interpreted: s. 144.025(2)(b), Stats.

The subject of this revision is the applicable dissolved oxygen criterion for the segment of the Oconto River from the bridge in Oconto Falls to the county highway "J" bridge. The Oconto River is classified to meet fish and aquatic life standards for water quality. Section NR 104.07(3) provides an exception or variance to the water quality criterion for dissolved oxygen. This variance to the dissolved oxygen criterion is no longer needed based on water quality analysis of the conditions impacting the oxygen content of this surface water. Therefore, s. NR 104.07(3) is being repealed. The effect of this revision is that the dissolved oxygen standard for this segment of the Oconto River will be 5 mg/l instead of 3 mg/l.

SECTION 1. NR 104.07(3) is repealed.

The foregoing rule was approved and adopted by the State of Wisconsin Natural Resources Board on May 25, 1989.

The rule shall take effect the first day of the month following publication in the Wisconsin administrative register as provided in s. 227.22(2)(intro.), Stats.
