





(1) ADAMS COUNTY. (a) *Amy pond*. Township 14 north, range 7 east, town of New Haven.




(2) BURNETT COUNTY. (a) *Crex Meadows*. Township 39 north, range 18 west, town of West Marshland.

(4) WAUKESHA COUNTY. (a) *Big Muskego Lake*. Township 5 north, range 20 east, town of Muskego.





(1) WAUSHARA COUNTY. (a) *Greenwood*. Township 19 north, range 8 east, town of Hancock.



**NR 15.022 No entry game refuge (Oct. 1 - Nov. 30); gun deer hunting permitted.** A game refuge is established in the following areas when posted with department signs and no person may hunt waterfowl at any time, or enter such areas for any reason from October 1 through November 30 except to hunt deer during the open season for hunting deer established in s. NR 10.01 (3) (e), trapping by permit in the area described in sub. (5), and except for the retrieval of legally killed or crippled game in posted retrieval zones.

(1) CLARK COUNTY. (a) *Sportsman's lake*. Township 29 north, range 1 west, town of Hoard.
