





NR 15.01 Year round game refuge. A game refuge is created in the following areas as posted with department signs and no person may hunt or trap upon such areas or have in possession or under control any gun or rifle unless the same are unloaded and enclosed within a carrying case, or any bow unless it is unstrung or enclosed within a carrying case.


(1) BROWN COUNTY. (a) *Bay Beach*. Township 24 north, range 21 east, city of Green Bay.




(b) *Suamico*. Township 25 north, range 20 east, town of Suamico.




(2) BURNETT COUNTY. (a) *Crex Meadows*. Township 39 north, range 18 west, town of West Marshland.



(8) GREEN LAKE COUNTY. (a) *Berlin*. Township 17 north, range 12 east, town of Seneca.




(b) *Maude R. Card estate*. Township 14 north, range 13 east, town of Mackford.




(10) JUNEAU COUNTY. (a) *Upham Woods*. Township 14 north, range 6 east, town of Lyndon.



(11) LA CROSSE COUNTY. (a) *Camp Decorah*. Township 18 north, range 8 east, town of Holland.




(19) WINNEBAGO COUNTY. (a) *U.W. - Oshkosh*. Township 17 north, range 16 east, town of Black Wolf.

Township 22 north, range 6 east, town of Grand Rapids.



NR 15.02 No entry wildlife refuge (Sept. 1 - Dec. 31). A wildlife refuge is established in the following areas when posted with department signs and no person may hunt waterfowl at any time, or enter such areas except for the retrieval of legally killed or crippled game in posted retrieval zones from September 1 through December 31 unless such areas are posted as open with department signs.

NR 15.11 Horicon Marsh fur farm. (1) A state fur farm to be known as the Horicon Marsh fur farm is established on all of the state-owned lands on the Horicon Marsh wildlife area in Dodge county as mapped and no person may hunt or trap any fur-bearing animals on such area unless authorized by a valid department permit. Any violation of the permit terms shall be deemed to be a violation of this section.




(2) The secretary shall cause the boundaries of the Horicon marsh fur farm as created and established by this section to be marked with signs posted for that purpose.

(3) This section shall not prohibit the department or its fully authorized agents, the armed forces of the national guard or of the United States, or any peace officers or any person summoned by a peace officer to assist him in making an arrest or in preserving the peace from entering and being on the above described Horicon marsh fur farm in the performance of official duties.

NR 15.12 University arboretum. A wildlife refuge is established in the following area and no person may hunt or trap upon such area or have in possession or under control thereon any firearm unless it is unloaded and completely enclosed within a carrying case or a bow unless it is unstrung or completely enclosed within a carrying case, but nothing herein shall prohibit, prevent or interfere with the department, its deputies, agents or employes in the destruction or removal of injurious animals.

NR 15.13 University Bay. Wildlife research in all phases, including the experimental harvest of wild animals and birds, may be conducted on lands described in s. NR 15.01 (5) (e) by the department and its agents and by the regents of the university of Wisconsin or their agents without restriction.
