ORDER OF THE STATE SUPERINTENDENT OF PUBLIC INSTRUCTION AMENDING RULES

The state superintendent of public instruction hereby renumbers PI 25.02 (14),
PI 25.06 (2) (a) and (b); renumber and amends PI 25.02 (11), (12), (13), PI 25.06 (2)
(intro.) and (c) to (e); amends PI 25.01 (1), PI 25.02 (9), PI 25.03 (1) (intro.), (a), (b) 1, 3,

5 (intro.) and (d), PI 25.04 (2), (5) and (6), PI 25.05 (1) (intro.) and (b) and (4), PI 25.06

(1) (a) (intro.), 1, 4 and 6, (b) to (d) and (3); repeal and recreates PI 25.02 (5); and
creates PI 25.02 (2m), (11) to (14), (17), PI 25.03 (3), PI 25.04 (7), PI 25.01 (1) (f),

PI 25.06 (1) (a) 7 and (2) (b), relating to programs for children at risk.

ANALYSIS BY THE DEPARTMENT OF PUBLIC INSTRUCTION

7 Statutory authority: ss. 118.153 (7) and 227.11 (2) (a), Stats.

Statute interpreted: s. 118.153, Stats.

1989 Wisconsin Act 31 amended the children at risk statutes as follows:

- 1. Expanded the definition of children at risk to specify criteria for identifying pupils in grades 5-8 and amended the definition of children at risk relating to absences and basic skill deficiencies.
- 2. Created performance criteria for children at risk programs serving children at risk in grades 5 and 6.
- 3. Permits districts with dropout rates between 2.5% and 4.99% to voluntarily submit children at risk plans to the state superintendent and be eligible for additional aids.
- 4. Increased emphasis on parent and community involvement in children at risk programs.
- Act 31 specifically required the state superintendent to promulgate rules defining the phrase "one or more years behind their age group in the number of credits attained or in basic skill levels" under s. 118.153 (1) (a) (intro.), the phrase "2 or more years behind their age group in basic skill levels" under s. 118.153 (1) (a) 2, and the phrase "one or more years behind their age group in basic skill levels" under s. 118.153 (1) (a) 3.

The rules specify that a pupil shall be determined to be behind his or her age group in the number of credits attained if the pupil has been held back one or more times at grade level and remains in this status. A determination of whether a pupil is behind his or her age group in basic skill levels must be based on a board approved plan of formal and informal assessments consistent with the district's objectives in mathematics and reading identified in the curriculum plan under s. PI 8.01 (2) k.

The proposed rules also clarify that programs leading to high school equivalency diplomas may not be included in the district's children at risk plan.

The proposed rules also include other technical, procedural and minor substantive changes.

- 19 involvement, pupil support services and program evaluation; and contracted services as
- 20 specified under s. PI 25.05 (1). This subsection does not provide authorization for
- 21 boards to contract for programs or services beyond statutory authority. Annually, the
- 22 board shall submit a report to the department that the funds were used as required.
