Ind 69.001 Scope. The fees established in the following sections of this chapter shall be paid to the department of industry, labor and human relations for providing those services authorized in the Wisconsin Statutes.

Note: All checks or money orders are to be made payable to Wisconsin Department of Industry, Labor and Human Relations.

Ind 69.01 Fee adjustment. Effective July 1, 1983, and thereafter, the fees specified in this chapter may be adjusted by the same percentage amounts, and on the same effective dates, as changes occur in the pay rate of employees of the state of Wisconsin.

Ind 69.02 Handling, copying and miscellaneous fees. (1) HANDLING FEES. The department may charge a \$13.00 handling fee to offset administrative costs.

(2) PHOTOCOPYING FEES. A photocopying fee of \$.15 per page may be charged.

(3) PLAN REPRODUCTIONS FEES. A fee of \$5.00 per sheet will be charged for plan reproduction.

(4) **MICROFILM FEES.** Microfilm prints of approved plans for the years 1967-1972 are available at the cost of reproduction.

(5) **MAILING LISTS.** Mailing lists may be obtained for a fee of \$20 for the first 1,000 names and \$5.00 for each 1,000 names thereafter. This fee shall be doubled, if gummed labels are requested.

(6) **INSPECTION AND COPYING OF PLANS AND SPECIFICATIONS.** The department shall allow inspection and copying of all plans, specifications and related materials filed with the department, except as follows:

(a) The department may restrict on a case by case basis, the right of inspection or copying of plans, specifications and related materials where the possible harm to the public interest outweighs the benefits of inspection or copying. The department will restrict inspection or copying of plans, specifications and related materials for the following types of buildings:

1. Banks, savings and loans, credit unions, securities dealers and other types or parts of buildings where large sums of money, negotiable securities or valuables are stored in secured areas;

2. Jails and other correctional institutions;

3. Public facilities regularly used for the storage or evaluation of evidence in criminal proceedings;

4. Armories;

5. Public broadcasting facilities;

6. Power generating facilities; and

7. Museums and libraries.

(b) The department shall allow inspection or copying of plans, specifications and related materials of all buildings in response to lawful subpoena, or in response to written requests from law enforcement agencies.

(c) Prior to any inspection or copying of plans, specifications and related materials, a written, signed application shall be obtained from the person requesting the inspection or copying. The application shall contain a general description of the premises for which inspection or copying is requested and the full name and address of the requester. The written request shall contain a statement that any information obtained from the inspection or copying shall not be used for any unlawful purpose or unfair competitive practice, and that the information set out therein is true and correct. The department will consider the information supplied in the request in conjunction with the type of buildings noted in par. (a) in determining whether the request for inspection or copying shall be granted. The department shall promptly transmit a copy of this statement to the owner and submitter of the documents being inspected or copied.

(d) The department may charge a reasonable amount to defray its costs in providing copies.

(2) Pursuant to s. 101.14 (5), Stats., the department shall in addition to any other fee charged for plan examination and approval for the construction of a new or additional installation or change in operation of a previously approved installation for the storage, handling or use of combustible or flammable liquids, as specified in sub. (1), collect a ground-water fee of \$100.00.

Ind 69.11 Petroleum product inspection fund, unfair sales enforcement program fund, environmental repair fund and petroleum storage environmental remedial action fund. The department shall collect a fee for each 50 gallons of petroleum product from which a sample is taken for the following programs:

(1) PETROLEUM PRODUCT INSPECTION AND UNFAIR SALES ENFORCEMENT PROGRAMS. Pursuant to s. 168.12 (1), Stats., the department shall collect a fee of 4.3¢ for each 50 gallons of petroleum product from which a sample is taken on or after June 1, 1988, for:

(a) The administration of the petroleum product inspection program; and

(b) The purpose of raising \$66,000 for each fiscal year for transfer to the department of agriculture, trade and consumer protection for administration of the Unfair Sales Enforcement Program.

(2) ENVIRONMENTAL REPAIR FUND. (a) Pursuant to s. 168.12 (1) Stats., the department shall collect a fee of 4.3¢ for each 50 gallons of petroleum product from which a sample is taken from June 1, 1988 to June 30, 1989, for the purpose of raising \$1,500,000 for fiscal year 1988-89. Any revenues in excess of \$1,500,000 shall be deposited in the Petroleum Storage Environmental Remedial Action Fund.

(b) The department will request at the end of fiscal year 1988-1989, an accounting from July 1, 1988 to June 30, 1989, of all expenditures made from the funds transferred to the department of natural resources for investigation, clean-up and environmental restoration actions.

(3) PETROLEUM STORAGE ENVIRONMENTAL REMEDIAL ACTION FUND. Pursuant to ss. 168.12 (1m) and 101.143 (2) (a), Stats., the department shall collect a fee of up to 11.4¢ for each 50 gallons of petroleum product from which a sample is taken on or after July 1, 1988, for the purpose of establishing and maintaining a sufficient level in the fund to pay actual and projected awards and administrative costs, the total of which is not to exceed \$7,500,000 in a fiscal year.

(4) SPECIFIED FEES AS LIENS ON PRODUCT INSPECTED. The fees specified in this section shall be a lien on the products inspected.

(5) CERTIFICATION FEE FOR PETROLEUM PRODUCT USERS. Persons applying for certification or recertification as a petroleum product user shall submit with the application for certification or recertification an annual fee (determined from the date of certification) of \$270.00 for each separate storage location.

Ind. 69.125 Certification of UST system specialities. All applicants for certification as a UST system installer, tightness tester, or remover, cleaner, reliner, inspector or site assessment provider shall submit, with the application form, fees as specified in this section.

(1) **APPLICATION AND INITIAL CERTIFICATION.** Persons applying for certification in one or more of the categories specified in sub. (2), shall submit a fee of \$100.00 for each 2 categories for which certification is requested.

(2) **CATEGORIES OF CERTIFICATION.** Persons may be certified in one or more of the following categories:

- (a) Installer;
- (b) Remover;
- (c) Tightness tester;
- (d) Cleaner;
- (e) Reliner;
- (f) Inspector; or
- (g) Site assessment provider.

(3) **EXAMINATION.** Upon determination of eligibility for examination for certification, fees shall be submitted for examination and reexamination as follows:

- (a) Initial examination \$10.00 per category
- (b) Examination retakes \$10.00 per examination per category

(4) **EXAMINATION AND TRAINING SEMINARS.** Fees shall be assessed on an individual basis from education and training programs the department sponsors or participates in.

(5) **RE-CERTIFICATION.** The recertification fee for 2 categories of certification shall be \$100.00 per person.

Ind 69.13 Ski lifts and towing devices. (1) **PLAN EXAMINATION FEE.** Fees for the examination of plans for ski lifts and towing devices shall be determined in accordance with Table 69.13-1.

(3) **LOAD TEST FEE.** The fee for certifying a load test shall be \$135.00.

(4) **CERTIFICATE OF OPERATION.** The department shall issue a certificate of operation upon receipt of a \$16.00 fee for each device and the inspection report indicating the device satisfies the minimum operating standards specified in ch. ILHR 33.

Ind 69.14 **Special inspections.** (1) **FEES.** For department costs incurred in the performance of special inspections, an additional amount will be charged to cover expenses, including travel time, mileage, meals and lodging. Travel expenses, however, will be limited to those allowed under department employe travel regulations. Fees for special inspections for alterations, fabrication, repairs, testing and quality assurance methods that are provided on request shall be determined in accordance with Table 69.14.
