

Order of the State of Wisconsin Ethics Board

Introduction

The Wisconsin Ethics Board issues an order to amend Eth 3.01 and 5.01 and to repeal SS 2.

Analysis prepared by the Wisconsin Ethics Board

Statutory authority: s. 19.48(1), Stats.

Statutes interpreted: Chapter 13, subchapter III, Stats.

The rule repeals rules previously promulgated by the Office of the Secretary of State. Those rules were promulgated prior to extensive statutory revisions that took effect on January 1, 1991 and the transfer of administration of the lobbying law to the Ethics Board. SS 2.01 and .02 contain definitions of terms that are, for the most part, defined by new statutory provisions. SS 2.03, .04, .05, .06, and .09 address issues relating to forms and procedures prescribed by the Secretary of State under statutory provisions that have now been amended. SS 2.07 and .08 interpret the extensively revised prohibited practices sections of the lobbying statute.

The rule also amends existing rules of the Ethics Board to reflect the Board's new address and new forms created for use by lobbyists and principals beginning January 1, 1991 reflecting new requirements of the lobbying law.

Text of Rule

SECTION 1. Eth 3.01 is amended to read:

Eth 3.01 Communications and documents addressed to board. (1) All written communications and documents intended for the board should be addressed to the State of Wisconsin Ethics Board, ~~125 South Webster Street~~ 44 East Mifflin Street, Suite 601, Madison, Wisconsin ~~53702~~ 53703-2800 and not to individual members of the board or its staff. All communications and documents delivered at the board's office are officially received.

SECTION 2. Eth 5.01 is amended to read:

Eth 5.01 Forms. Each of the following forms may be obtained from the board, ~~125 South Webster Street~~ 44 East Mifflin Street, Suite 601, Madison, Wisconsin 53702 53703-2800.

- (1) Statement of Economic Interests filed by candidates and continuing state public officials (Eth 1).
- (2) Statement of Economic Interests filed by nominees and new state public officials (Eth 2).
- (3) Quarterly Report of Economic Transactions (Eth 3).
- (4) Request to Examine Statements of Economic Interests (Eth 4).
- (5) Principal Registration (Eth 5).
- (6) Principal Authorization (Eth 6).
- (7) Lobby License Application (Eth 7).
- (8) Lobby Activity Information form (Eth 8).
- (9) Daily Log of Lobbying Activities for use by Lobbyists (Eth 9).
- (10) Statement of Lobbying Activities and Expenditures with Daily Log of Lobbying Activities for use by Employers (Eth 10).
- (11) Identification of Legislative Liaisons to be filed by state agencies (Eth 11).

SECTION 3. Chapter SS 2 is repealed.

Effective Date

This rule shall take effect on the first day of the month after publication in the Wisconsin administrative register.
