ORDER

An order of the Medical Examining Board to amend Med 7.08 (3) of the administrative code relating to supervising physical therapist responsibilities.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b), 227.11 (2) and 448.04 (1) (e), Stats.

Statutes interpreted: s. 448.04 (1) (e), Stats.

In this order the Medical Examining Board is amending s. Med 7.08 (3) to provide for proper supervision of unlicensed physical therapists who hold a temporary certificate and require direct, on premise supervision. The Medical Examining Board and the Physical Therapy Examining Council believe that it is not possible to provide appropriate and adequate supervision with more than 2 physical therapists.

These rules are modeled after s. Med 8.10 (1) which limits a medical doctor to supervise no more than 2 physician's assistants.

TEXT OF RULE

SECTION 1. Med 7.08 (3) is amended to read:

Med 7.08 (3) The holder of a temporary license to practice physical therapy under supervision may practice physical therapy as defined in s. 448.01 (1) (e), Stats., providing that the entire such practice is under the supervision of a person validly holding a regular license to practice physical therapy in this state. No physical therapist may supervise more than 2 physical therapists who hold temporary licenses. Such supervision shall be direct, immediate, and on premises.

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.22 (2) (intro.), Stats.
