General Summary of Rule. The purpose of Chapter Trans 112 is to establish the administrative interpretation of Chapter 343, Stats., Department of Transportation (Department) in relation to the issuance of motor vehicle operator licenses to persons who have a medical condition that may affect their ability to exercise reasonable control over a motor vehicle. It establishes medical standards and a medical review process, including licensing categories which define functional ability levels.

Trans 112 currently prohibits any person convicted of OWI from obtaining a passenger endorsement to a Commercial Driver License for a period of two years following the conviction. This rule provision parallels the current license availability restrictions governing school bus drivers. This parallel exists because many non-school bus drivers, such as transit system drivers, drive children to and from school.

This requirement may adversely impact some drivers who have been convicted of OWI in their personal vehicles within the past two years and who were not subject to such regulation at the time of their offense. As a result, if the rule is not amended, some transit bus drivers may lose their jobs for actions which, at the time committed, they could not have anticipated would affect their ability to earn a living.

This rulemaking creates section Trans 112.05(3)(bm) to provide that, for purposes of passenger endorsements, the Division of Motor Vehicles shall count only OWI convictions occurring on or after April 1, 1992. This will give all bus drivers an opportunity to know the effect of an OWI on their ability to continue working before committing the offense. This rulemaking will not affect the statutory prohibition on the issuance of a school bus license to any person that has been convicted of an OWI within the past two years.

Fiscal Impact. The Department anticipates no fiscal effect from the promulgation of this rule.

<u>Final Regulatory Flexibility Analysis</u>. These rule amendments will have no adverse impact on small businesses.

Trans 112.05(3)(bm) For purposes of determining eligibility for a passenger endorsement under par. (b)1 to 3, the department shall not count violations committed prior to April 1, 1992.
