An order of the Accounting Examining Board to amend Accy 8.04 (1) of the administrative code relating to the educational requirements of certified public accountants in foreign countries to qualify for a certificate in Wisconsin by endorsement.

Analysis prepared by the Department of Regulation and Licensing.

ANALYSIS

Statutes authorizing promulgation: ss. 15.08 (5) (b) and 227.11 (2) (a), Stats.

Statutes interpreted: ss. 442.04 (4) (c) and 442.05, Stats.

This proposed order of the Accounting Examining Board clarifies the education required of applicants certified to practice as a public accountant in a foreign country in order to qualify for a certificate by endorsement in this state under ss. 442.04 (4) (c) and 442.05, Stats.

The last sentence in Accy 8.04 (1) currently states that the education received by a foreign candidate "...must be established with the board as being appropriate for United States practice." The rule does not contain any objective criteria by which this determination is to be made. Accordingly, in order to provide an objective and standard approach to the evaluation of the foreign education received, the proposed language refers to the specific courses set forth in Accy 7.03 (1).

TEXT OF RULE

SECTION 1. Accy 8.04 (1) is amended to read:

Accy 8.04 (1) Education qualifications in foreign countries are not comparable to those in Wisconsin. As no foreign school is accredited by the north central association of schools and colleges or its regional equivalent, evidence of acceptance without deficiency into a graduate program in a school accredited by the north central association of schools and colleges or its regional equivalent will be accepted as evidence of equivalence for a bachelor's or higher degree. The accounting major must be established with the beard as being appropriate for United States practice. The education acquired must constitute the reasonable equivalence of a resident major in accounting as set forth in s. Accy 7.03.

The rules adopted in this order shall take effect on the first day of the month following publication in the Wisconsin administrative register, pursuant to s. 227.22 (2) (intro.), Stats.
